The Cabinet,

Pursuant to the perusal of the Constitution;

Federal Law No. 1/1972 on the competencies of the Ministries and powers of the Ministers, and its amendments;

Federal Law No. 18/1981 on the regulation of the commercial agencies, and its amendments;

Federal Law No. 6/1983 on determining the fees imposed on certificates of origin for national products of the United Arab Emirates;

Federal Law No. 37/1992 concerning trademarks and its amendments;

Federal Law No. 7/2002 concerning copyrights and neighbouring rights, and its amendments;

Federal Law No. 17/2002 concerning the regulation and protection of industrial property for patents and industrial designs and models, and its amendments^[4 p.14],

Federal Law No. 12/2014 on the Regulation of the Auditing Profession, and its amendments;

Federal Law No. 2/2015 on Commercial Companies and its amendments;

Federal Law No. 14/2016 on the violations and administrative fines at the Federal Government;

Federal Law No. 11/2019 on the rules and certificates of origin.

Federal Decree-Law No. 26/2019 on Public Finance;

Cabinet Decision No. 19/2013 concerning the fees prescribed for the issuance of State certificates for rough diamonds;

Cabinet Decision No. 51/2019 concerning the fees for services provided by the Ministry of Economy; and

Based on the proposal of the Minister of Finance, and the approval of the Council of Ministers;

Has decided:

Article 1 - Definitions

In application of the provisions of this Decision, the following terms and expressions shall have the meanings assigned to them, unless the context requires otherwise:

State: The United Arab Emirates.

Ministry: The Ministry of Economy.

Minister: The Minister of Economy.

Article 2 - Service Fees

In return for the services, listed in the Schedule attached to this Decision, provided by the Ministry, the fees assigned to each of them shall be collected.

Article 3 - Administrative Fines

In the event of commission of the violations listed below, the administrative fines assigned to each of them shall be imposed:

Article 4 - Grievance

Any interested party may file a written grievance before the Ministry against any of the administrative fines imposed on them as mentioned in Article (3) of this Decision, within (10) days from the date of notification of the fine against which grievance is filed. Such grievance shall be reasoned and all supporting documents shall be attached thereto; and it shall be decided upon within (20) days from the date of filing it, according to the procedures in force at the Ministry.

Article 5 - Amendment of Administrative Fees and Fines

The Council of Ministers shall have competence to make any amendments to the administrative fees and fines set forth in this Decision, whether by addition, deletion, or amendment.

Article 6 - Final Provisions

- a- The fees and fines mentioned in this Decision shall be collected by the means determined by the Ministry of Finance.
- b- The Minister of Finance shall be commissioned, in coordination with the Minister, to allocate a portion of the technical search fees for patents referred to in the Schedule of Fees attached to this Decision, in order to spend on the costs of patents, provided that the revenues resulting from these fees go to the State's public treasury.
- c- For the purposes of collecting the administrative fees and fines mentioned in Articles (2) and (3) of this Decision, part of a day shall be considered a full day, and part of a month shall be considered a full month.

Article 7 - Implementing Decisions

The Minister shall issue the decisions deemed necessary for the implementation of the provisions of this Decision.

Article 8 - Abrogation

- 1- With the exception of Cabinet Decision No. 19/2013 concerning the fees for issuing State certificates for rough diamonds, Cabinet Decision No. 51/2019 concerning the fees for services provided by the Ministry of Economy shall be abrogated^[5 p.14].
- 2- Any provision that is contrary to or inconsistent with the provisions of this Decision shall be abrogated.

Article 9 - Publication and Enforcement

This Decision shall be published in the Official Gazette and shall come into force as of 05/04/2020.
