- **Written confirmation of Membership and Good Standing with the Bahamas Bar Association.**
- **Written confirmation that you/the firm have not been the subject of any previous disciplinary measures by the Bahamas Bar Association.**
- **Date called to The Bahamas Bar.**
- **Confirmation that there are no outstanding Judgments against self or firm.**
- **Professional Indemnity Insurance of minimum \$1,000,000.**
- **Evidence of minimum of five years experience in a Private Practice**
- **Two Bank credit references (one must be from the firm's Bank).**
- **Copy of the Company's latest annual Business License.**
- **Written confirmation of whether you/the firm have had to claim on your Professional Indemnity Insurance for a legal opinion previously rendered. If yes, a brief summary of the matter is to be provided.**
