Fender warrants that the Fender cable you have purchased shall be free of any defects in material and workmanship for as long as it is owned by the original retail purchaser, subject to the limitations set forth herein (the “Warranty”). Defective cables will be repaired or replaced without charge, at Fender’s discretion, with a like or comparable product by presenting your proof of purchase to the Fender office located in your country or the Authorized Fender Dealer from whom the cable was purchased. Any repair or service performed by any person or entity other than Fender is not covered by this Warranty. All transportation, insurance and freight charges associated with warranty service and repairs on Fender cable products are the responsibility of the purchaser. This Warranty becomes void if the product has been damaged by alteration, misuse, accident, or neglect.
