## **INSTRUCTIONS**<sup>1</sup>

## (WHEN POWER OF ATTORNEY IS EXECUTED IN INDIA BY NON RESIDENT INDIANS)

- 1. The Attorney should be preferably a resident of the city /town from where the loan is processed
- 2. The Power of Attorney is to be executed on a non-judicial stamp paper of the requisite value as per the stamp duty prevalent in the respective state
- 3. The format to be filled in completely and each page to be signed by all the Grantor(s) (All NRI Applicant(s)).
- 4. The power of attorney holder to sign on last page only after it is received in India.
- 5. It is mandatory that the Power of Attorney should also be notarized by a Notary Public in India.

(WHEN POWER OF ATTORNEY IS EXECUTED OUTSIDE INDIA BY NON-RESIDENT INDIANS)

- 1. The Attorney should be preferably a resident of the city /town from where the loan is processed
- 2. The Power of Attorney format should be printed on plain white sheet of paper.
- 3. The Grantor must visit any of the authorized official of the Indian Embassy / Indian Consulate / Notary Public in the country where the Grantor resides.
- 4. The Grantor must sign each page of the format in front of the official. The officials will then have to affix their stamp and signature on the Original format. If the stamp of the Notary Public does not bear his name, then principal office address and notary registration number must be written by hand.
- 5. The Grantor must affix the Attorney's passport size photograph and cross sign across the same. The Original format has to be sent to India via courier where the Attorney signs on the last page. Then the same original format needs to be notarized by the Notary Public in India or adjudicated as applicable in the state where POA document is executed.
- 6. Once submitted to ICICI Bank, ICICI Bank official (Credit Team) to send scan copy to grantor and obtain confirmation on the POA document through registered email id.
- 7. The following para needs to be written on all legal documents signed by the Attorney Holder.
