

TERMS AND CONDITIONS RELATING TO AADHAAR UPDATION

(Last Updated on-2nd June 2018)

I/We hereby provide my voluntary consent to ICICI Bank to use the Aadhaar details provided by me for authentication of my identity with Unique Identification Authority of India (UIDAI) for the purpose of this Credit Card application form and other terms and conditions including but not limited to usage, purpose and authentication of Aadhaar.

By consenting to these terms and conditions, I/We agree to provide my voluntary consent and authorise ICICI Bank for:

- A. Using my Aadhaar details for verifying and authenticating my identity with UIDAI's Aadhaar based authentication system;
- B. Updating the Aadhaar details provided by me in the Credit Card Account/ Customer ID opened pursuant to this Credit Card application form;
- C. Sending SMS alerts regarding this Credit Card application form on the mobile number registered by me with ICICI Bank for this purpose; and
- D. Using, exchanging and sharing my Aadhaar details with National Securities Depository Limited (NSDL) for the purpose eSign, concerned regulatory and/ or statutory authorities as may be sought by them and/ or required under applicable law(s).

By consenting to these terms and conditions, I/We agree with the below terms pertaining to sharing of my Aadhaar related information and purpose of usage of my Aadhaar related information.

- A. I/We acknowledge that my Aadhaar details will be submitted to the Central Identities Data Repository / UIDAI for authentication, through Yes/No authentication facility (using demographic, biometric, OTP or multi-factor authentication) or e-KYC authentication facility (using biometric information and / or OTP), as may be applicable and for updation of Aadhaar details.
- B. I/We agree and acknowledge that upon authentication of Aadhaar details, UIDAI may share with ICICI Bank, information in nature of my demographic information (including photograph) which may be used by ICICI Bank for Know Your Customer (KYC) verification as identity/address proof for the purpose of this Credit Card application form.
- C. I/We understand that my (i) biometric details will not be stored by ICICI Bank; (ii) Aadhaar number. will not be shared with any third party except as provided under applicable laws and/or NSDL for the purpose of Aadhaar related electronic signature; and (iii) Aadhaar information shall not be used for any purpose other than mentioned above.
- D. I hereby understand that my request for updation of Aadhaar details will not be processed, if(a) Aadhaar details provided by me for opening Credit Card Account is incorrect and/or incomplete;(b) authentication with UIDAI fails due to mismatch of my details with UIDAI data; (c) there is technical failure while authenticating Aadhaar details with UIDAI.
- E. I/We hereby declare and undertake that the eSign facility is being provided through a third party platform and ICICI Bank shall not be liable for any mismatch in eSign or failure of authentication in any manner whatsoever.
- F. I/We hereby declare that the information furnished by me to ICICI Bank is true, correct and complete. ICICI Bank does not take any responsibility and shall not be held liable for

any claims whatsoever, should the details provided by me are incorrect and/or incomplete.

G. I understand that in case of any correction, dispute, query or complaint regarding the Aadhaar updation, I shall address the same to the phone banking team of ICICI bank or visit the nearest ICICI Bank branch.

H. I understand that these terms and conditions shall be in addition to and not in substitution/derogation of the Terms and Conditions and MITC.
