### Uproar over bar bribery charges against govt Audio clip surfaces of a bar owners association member seeking money from others to pay kickback to LDF govt EXPRESS NEWS SERVICE @ T'Puram Bar Association Idukki district president Ani Mon to members

A decade after the bar bribery scandal rocked the then UDF government led by Oommen Chandy, the LDF government

has been caught in a similar situation after an audio clip, purportedly sent by a bar association leader asking money from bar owners to pay kickbacks to the government for a favourable liquor policy, surfaced on Friday. The Opposition UDF, includ-

ing IUML, flayed the LDF and demanded the resignation of Excise Minister M B Rajesh alleging corruption. The BJP termed it 'Delhi model bribery'. However, the CPM termed the charges baseless, while Rajesh asked the state police chief to conduct a detailed probe into the allegations. Both CPM and Rajesh said they suspected a conspiracy behind the allegation.

The leaked clip, suspected to be sent by Federation of Kerala during the executive meeting of the association in Kochi on Thursday, asks bar owners to give ₹2.5 lakh each to tweak the liquor policy and fulfil their demands such as scrapping of the dry-day policy and extending operations of bars from 11pm to midnight.

The speaker says a new liquor policy will be declared and implemented after the Lok Sabha elections with many favourable changes. To make it happen, what needs to be given should be given," says the speaker. No sooner did the clip surface than the UDF targeted Rajesh, with KPCC president K Sudhakaran demanding his resignation, alleging that the new liquor policy was to be implemented after taking ₹25 crore as kickback from bar owners.

"The government move aims to facilitate huge profits for bar owners, by doing away with the dry-day policy, opening pubs in

IT parks and extending bar timings," alleged Sudhakaran. Leader of Opposition V D Satheesan alleged corruption to the tune of ₹20 crore, as owners of the state's 801 bars were allegedly being asked to pay ₹2.5 lakh each.

"The fund collection demand will not be made without the knowledge of someone in the government," Satheesan alleged in Kochi. He also claimed that those who had accused former finance minister K M Mani in a ₹1-crore corruption scandal were now involved in a ₹20-crore bribery scam.

"Where is the currency counting machine now? Is it with CM Pinarayi Vijayan, the excise minister or at the AKG Centre,' he asked. "The first Pinarayi government granted licenses to 669 bars, and the second gave it to 130 bars. Relaxation in liquor policy aims to benefit bar own-

Rajesh rejected the allegations and said the government is vet to begin discussions on the policy. "For the past one month, there have been media reports on the policy. If anyone tries to collect money on the basis of such reports, the government will take strong action," Rajesh said. "The government filed 52 cases against bars in the past six months. Some might be uneasy with the government taking action against such people," he said.

He said contrary to UDF's claims, the LDF government had increased licence fee from ₹23 lakh to ₹35 lakh. "In the last liquor policy, the fee was hiked by ₹5 lakh. How can UDF say the government is trying to tweak the policy in bar owners' favour?" Rajesh wondered. The CPM leadership too termed the allegations baseless and dismissed calls for Rajesh's resignation.

STRONGLY objecting to the union government's decision to consider Kerala's proposal to conduct an environmental impact assessment (EIA) study for constructing a new dam at Mullaiperiyar, Chief Minister MK Stalin on Friday warned of strong legal action, including contempt petition in the Supreme Court, if Kerala government, Union Ministry of Environment and Forests (MoEF) and its Experts Appraisal Committee (EAC) fail to adhere to the earlier orders of the SC on

In a letter to Union Forest Minister Bhupender Yadav, Stalin urged him to instruct the officers concerned to drop the item to consider the EIA for the new dam from the agenda of the EAC meeting scheduled for May 28.

The CM also urged the MoEF to not take up any such proposals from Kerala in the future.

"Our objections regarding the issue have already been communicated in detail by the Additional Chief Secretary, Tamil Nadu Water Resources Department, to the MoEF Secretary and other members of the EAC," the CM said in his letter.

Pointing out that taking up Kerala's proposal for a new dam for consideration will violate the orders of the Supreme Court, Stalin said, "We are informed that the EAC, under the aegis of the MoEF, has included the above proposal by M/s Irrigation Design & Research

Board (IDRB), Government of Kerala, in the agenda of its upcoming meeting. The proposal for constructing a new dam by Kerala, purportedly in lieu of the existing Mullaiperiyar dam, is against the directions

The letter said, "The existing dam has been repeatedly found to be safe in all aspects by various expert committees and has been ruled so by the SC in its judgments dated February 27, 2006, and May 7, 2014. Later in 2018, when Kerala made an attempt to get approval for the ToR for EIA study for the proposal for a new dam, the issue was taken up by Tamil Nadu at the SC and it was clearly ruled that any such step would require SC's permission," Stalin pointed out. He also reiterated that the

current act of Kerala on EIA study for a new dam would definitely be in contempt of the orders passed by the SC. Palaniswami recalled the legal battles waged by the AIADMK government under J Javalalithaa starting with the demand for raising the storage level to 142 feet and told the DMK government to make efforts to increase it to 152 feet, which was the level before the dispute broke out in the early 1980s

Other political parties like the Congress and the PMK had already objected to the Union Government considering Kerala's proposal and urged the State government not to allow the construction of a new dam and demolish the existing one.

### HC split verdict on detention of Savukku Shankar

THE Madras High Court on Friday delivered a split verdict on the legality of detention of jailed YouTuber 'Savukku' Shankar under Goondas Act in the wake of his arrest in five different cases including ones related to denigration of women police personnel and possession of ganja

Justice GR Swaminathan, heading the division bench, quashed the detention order on the grounds of procedural lapses as he termed 'non-application of mind' by the authority concerned, the Greater Chennai Police Commissioner, in approving the detention order in a hurry. He also held that Shankar's activity is not a threat to public order which would warrant his detention under the Goondas Act.

The dissenting judge, Justice PB Balaji, underscored the need for granting time for the prosecution to file counter-affidavit before hearing the case as per the usual practice. The split verdict was passed on a habeas corpus petition (HCP) filed by the YouTuber's mother A Kamala seeking to quash the detention order passed on May 12, 2024. Even as the arguments were under way, Justice Swaminathan hinted at what was in store as he pointed out that even without his detention, the detenu has little chance to walk out of prison as five cases were already booked against him.

## 25 from Vizag trafficked to Cambodia return home

AS many as 25 of the total 58 individuals from the Port City. dia, landed at Visakhapatnam International Airport on Friday evening.

A total of 150 people from Andhra Pradesh were lured with false promises of employment in Singapore, only to find themselves held captive, tortured, and coerced into cybercrimes targeting Indian citizens

in Cambodia. Stressing that the rescued individuals will be treated as victims, Visakhapatnam Commissioner of Police Dr A Ravi Shankar explained, "We will not file cases against them, as they went there seeking legitimate employment. Our focus

will be on gathering details from them to take action against the actual traffickers."

Further, he asserted that the in contact with the police through WhatsApp, will also be rescued shortly after all the legal proceedings are completed. The duration of captivity

varied between one year and three months.

Giving an account of thier experiences, the CP said the victims were tortured by being deprived of food, locked in dark rooms, and physically beaten with baseball bats. He said the victims received meals based on their performance. "Underperforming victims received food only once a day, while those who defrauded

many were given two meals a

day," he explained.

### Four of a family among 8 die in Chikkamagaluru, Haveri road accidents

EIGHT people died in two road accidents in Chikkamagaluru and Haveri districts on Friday. Four members of a family died on the spot and 12 were injured in the accident involving two cars and a truck on NH 173 near Kottigehara in Chikkamagaluru district. They were travelling in Maruti Omni and Alto cars. After the van rammed the truck, the car hit the van from behind.

The deceased have been identified as Hampaiah, 65, Prema, 58, Manjaiah, 60, and Prabhakar, 45. The injured were shifted to hospitals in Mangaluru. They were returning to Channapatana village in Holalkere taluk after visiting temples in Dharmasthala.

Four members of a family died when their car fell off a bridge on the outskirts of Ranebennur in Haveri district. The deceased have been identified as Suresh Jadi, 43, Ishwarya Barki, 16, Chetan Sumangadi, 7, and Prabhuraj Sumangadi, 45. Four people were injured in the accident.
