Pune: Pune police have minor in the Porsche car accident case after confirmation that his blood samples were replaced with hers, the city police chief said on Saturday. She is likely to be produced in a court during

As part of their probe, the police also spoke to the minor for about an hour at the observation home, where he has been sent till June 5, in his mother's presence.

Citing their investigation into the accident, Commissioner of Police Amitesh Kumar said the juvenile's blood samples were swapped with those of his mother.

Police had told a local court two days ago that the blood samples of the 17-year-old juvenile were exchanged with those of a

"We will conduct the minor's inquiry inside the home in the presence of his mother," Additional Commissioner of Police (Crime) Shailesh Balkawade had said before police spoke to the minor.

Juvenile Justice Board (JJB) on Friday permitted the police to probe the teenager. Under the quiry of a minor has to be conducted in the parents'

Two IT professionals were killed in the early hours of May 19 in Kalyani Nagar in Pune after a Porsche allegedly being driven by the minor, who the police claim was drunk, rammed into their two-wheeler.

The minor's father, realtor Vishal Agarwal, and grandfather Surendra Agarwal have been arrested for allegedly kidnapping the family's driver and putting pressure on him to take the

A court on Friday remanded the teenager's father and grandfather in judicial custody for 14 days after their police custody ended.

Police have also arrested Dr Ajay Taware, then head of the department of forensic medicine at Sassoon General Hospital, medical officer Dr Shrihari Halnor and employee Atul Ghatkamble for allegedly manipulating the minor's blood samples to show that he was not drunk at the time of the accident.

News Kochi: The Kerala government on Saturday reiterated that no animal sacrifice was held near a temple in the northern part of the state as claimed by Karnataka Deputy Chief Minister D K Shivakumar.

Kerala Devaswom Min-Radhakrishnan said that Shivakumar had made a huge allegation that animal sacrifice was performed near the Rajarajeshwara temple at Taliparamba in Kannur district of the state against him, CM Siddaramaiah and the Congress government in Karnataka.

"We investigated the claim and also contacted the Malabar Devaswom Board. The preliminary report we got states that nothing like that has happened in or near the temple. The Devaswom Board also confirmed it," the minister said.

Jalpaiguri cocoa saplings to seed Assam chocolate

News Jalpaiguri: Cocoa saplings from a research institute in Jalpaiguri will be sent to Assam for cultivation and the plant's seeds will be used for making chocolates and other items.

According to sources, Mondelez India Foods Private Limited, a subsidiary of Mondelez International which owns the globally famous Cadbury brand, will set up a plant in Assam to produce chocolates, beverages and other products.

"Along with the plant, the company has also decided to set up a cocoa plantation to use the tree's seeds, a primary ingredient of chocolates and similar products, at the site in Assam. For

the plantation, they have placed an order for 5,000 cocoa saplings with us," said Arun Kumar Sit, the scientist in charge of the CPCRI (Central Plantation Crops Research Institute) Research Centre located at Mohitnagar, on the outskirts of Jalpaiguri.

Headquartered Kasaragod in Kerala, the CPCRI conducts research on coconut, areca nut, coco cashew and some other crops. It has several research centres in the country, including the one in
