Spain beat Georgia in style

Spain recovered from conceding an early own-goal to beat Georgia 4-1 for a spot in the Euro 2024 quarterfinals, ending one of the tournament's most compelling underdog stories. Goals from midfielders Rodri and Fabian Ruiz brought Spain back into the game after Robin Le Normand's own-goal in the 18th minute had given Georgia a shock lead. Nico Williams and Dani Olmo took the game out of Georgia's reach with two more goals late in the game as heavy rain fell. Spain will play host nation Germany in the quarterfinals on Friday in Stuttgart. The loss ends Georgia's first ever major tournament campaign, which included a 2-0 upset win over Cristiano Ronaldo's Portugal. Despite the lopsided score, Georgia goalkeeper Giorgi Mamardashvili had another standout game with nine saves to prevent a rout. Spain had beaten Georgia 7-1 in qualifying last year, but this

game was a close contest until the last 20 minutes and testament to Georgia's rapid improvement under coach Willy Sagnol. Playing its fourth game of Euro 2024, Spain had yet to concede a goal all tournament. That soon changed when Otar Kakabadze surged down the right flank for Georgia and crossed low. Le Normand chested the ball past his own

goalkeeper, with the defender apparently distracted by Khvicha Kvaratskhelia arriving behind him to meet the cross. Spain took its time to get back into the game, but Rodri -- back from a one-game suspension -- leveled the score in the 39th with a low shot from just outside the box. Georgia remained a threat on the counter, including with an

audacious shot from the half-way line by Kvaratskhelia, but Spain midfielder Ruiz made it 2-1 in the 51st when he rose unmarked to meet a cross from the 16-year-old Lamine Yamal. Needing a goal, Georgia had to open up its compact defensive formation and conceded twice more as Williams scored in the 75th and substitute Olmo eight minutes later. After the final whistle, Georgia's players gathered in front

of their fans for a slow-clap chant reminiscent of another European Championship underdog - Iceland - when it beat England in 2016. **France in quarters** France were helped by Jan Vertonghen's own goal as they beat Belgium 1-0 in their Round of 16 match and entered the quarterfinals of the Euro 2024. When it seemed the match was heading towards extra time, Vertonghen's own goal lit up the proceedings and paved the way for France to progress.

Alcaraz opens Wimbledon with win

The 2024 edition of Wimbledon started on Monday, with defending champion Carlos Alcaraz and past Grand Slam title winners Coco Gauff and Emma Raducanu all set to play matches at Centre Court. Aryna Sabalenka, the two-time Australian Open champion who was seeded third at the All England Club, withdrew on Monday because of an injured shoulder. No. 9-seeded Maria Sakkari was among the early winners, beating McCartney

Kessler 6-3, 6-1. "We could name like 20, 25

girls that could win the tournament right now," Sakkari said.

Alcaraz just won his third major championship at the French Open three weeks ago. He defeated Novak Djokovic in last year's final at Wimbledon. Alcaraz faces qualifier Mark Lajal of Estonia on Day 1 on the All England Club's grass courts. Raducanu won the 2021 U.S. Open at age 18, but she has been dealing with various injuries since then. Her scheduled opponent - 22nd-seeded Ekaterina Alexandrova - withdrew Monday morning because of illness. Alexandrova was replaced by Renata Zara-

zua, a so-called "lucky loser" from the qualifying tournament. Gauff, who won the U.S. Open last September, closes out the day's schedule in the main stadium against Caroline Dolehide in an all-American matchup. No. 1-ranked Jannik Sinner is also on Monday's schedule, playing Yannick Hanfmann at No. 1 Court. In early results, No. 8-seeded Casper Ruud beat Alex Bolt 7-6 (2), 6-4, 6-4. Unseeded Canadian Denis Shapovalov eliminated No. 19 Nicolas Jarry 6-1, 7-5, 6-4.

New star in the making

The 16-year-old Naishaa Kaur Bhatoye is fast emerging on the Indian junior badminton scene

Indian badminton has been on an upswing in the last decade with the exploits of the likes of PV Sindhu, HS Prannoy, Lakshya Sen and the doubles pair of Satwiksairaj Rankireddy and Chirag Shetty. Now, a Mumbai lass all of 16 is taking baby steps to fulfill her ambitions of reaching the heights of her fellow countrymen.

The name is Naishaa Kaur Bhatoye and she's one of the fastest emerging stars on the Indian badminton circuit at the moment having won the Spanish Junior Open and Cyprus Junior Open this year. She had also clinched the France Open in 2023 and bagged quite a few international medals as well.

The 16-year-old is currently training at the Gopichand Academy in Hyderabad. Naishaa, who won triple titles at the recently concluded CCI-GMBA District Badminton Championship 2024, started playing badminton at the age of seven.

"I started playing in my society and that's how I started playing the sport and I pursued my career more seriously when I went to train at the Prakash Padukone Academy," Naishaa said. "I was there for 3-4 years and later I was not sure whether I should pursue it or not. It was just a hobby for me and then some taking part in some tournaments and that's how I felt I wanted to become a player."

The 11th standard student of St Gregorius School, Chembur is the India No 2 in under-17 category while she is the World No 5 in the under-19

level. "After 3-4 years at the Padukone Academy, I started to play the all-India level and I was performing well and became the India No 1 in under-13 category and then I was called Gopichand academy to train there full time," she added. Naishaa, who is a native of Hoshiarpur in Punjab, aspires to play some of the major top-draw badminton tournaments on the international circuit. "I intend to play World Championships, All-England juniors and hopefully the Olympics someday," Naishaa revealed. The promising player feels the strong point of her game is her attacking approach. "I feel attacking approach is my biggest strength and I also have a strong backhand," she added.
