**Kanpur:** In a much-needed good news for wildlife lovers, Lioness Neerja gave birth to four cubs at the Etawah Safari Park in Uttar Pradesh on Friday night. With this, the number of lions at Etawah Safari Park has increased to 16.

Safari director Anil Patel said mating of the lioness with the male lion Kanha, which came from Gujarat, took place between Feb 12 and Feb 15, 2024.

### Defamation case: Court asks Rahul to appear on June 7, grants bail to Siddaramaiah, DKS

**Bengaluru:** A court here on Saturday directed Congress leader Rahul Gandhi to appear before it in a defamation case filed by the BJP, and granted bail to Karnataka Chief Minister Siddaramaiah and his deputy D K Shivakumar in connection with the matter.

Rahul was asked to appear before the court on June 7 in connection with the case. The defamation case on alleged false advertisements was filed by BJP general secretary Keshav Prasad. While Siddaramaiah and Shivakumar appeared in person before the special court for people's representatives in Bengaluru, Rahul, who was supposed to appear, did not turn up.

Congress advocates argued that Rahul was attending the INDIA bloc meeting in New Delhi, and he is also a contestant in the Lok Sabha polls. They requested the court for exemption from Saturday's hearing and promised that the Congress leader would be present on the next date. The court granted an exemption to Rahul and directed him to be present before it on June 7.

### Court reserves order on Kejriwal's bail plea

#### Delhi CM To Be Back In Jail Today

**New Delhi:** After 21 days of freedom, AAP convener and Delhi chief minister Arvind Kejriwal will be back in the Tihar jail on June 2 in the excise policy case as a city court Saturday reserved its order on his plea seeking interim bail on medical grounds.

A day before he surrenders before the bail authorities, Kejriwal held a meeting of the AAP's political affairs committee at his residence this morning. He later attended the INDIA bloc meeting at Congress president Mallikarjun Kharge's home.

Kejriwal was released from the jail on May 10 on interim bail granted by the Supreme Court for campaigning in the Lok Sabha polls.

The city court on Saturday reserved for June 5 its order on an application moved by Kejriwal seeking interim bail in the money laundering case linked to alleged excise policy scam. The court observed that the plea was for interim bail on medical grounds and not for the extension of the interim bail granted by the Supreme Court.

### Seven dead as boat capsizes in MP's Sheopur

**Sheopur:** Seven persons, including five children, were killed after a boat carrying 11 persons capsized in Sheopur district on Saturday, a police official said.

Four others were rescued in the incident which took place at 4:30pm in Manpur, some 40 kilometres from the district headquarters, superintendent of police Abhishek Anand said.

"The seven deceased comprise five children in the 4-15 age group, a 35-year-old man and a 30-year-old woman. The deceased are local residents and members of the Mall (gardeners) community. They had come to a nearby village to mourn the death of a person," the SP said.

"Local residents have told us a storm or a whirlpool may have toppled the boat. Survivors have said there were 11 persons in the boat. However, a team of the state disaster response force is still camping at the site," he added.

Meanwhile, Madhya Pradesh chief minister Mohan Yadav asked officials to carry out search and rescue operations on a war footing and also directed state energy minister Pradyuman Singh Tomar to rush to the site.

### Goel sends ambulance to Kejriwal after CM's bail extension plea on medical grounds

**New Delhi:** Senior BJP leader Vijay Goel on Saturday sent an ambulance to take Delhi chief minister Arvind Kejriwal to hospital for medical tests after the AAP leader claimed he might be suffering from some serious ailments. The police, however, stopped the ambulance and Goel en route to the chief minister's official residence in Civil Lines here.

Goel alleged that Kejriwal was "creating drama" by citing health issues to gain people's sympathy. "This ambulance was to take Kejriwal to any hospital where all his tests can be done within two to four hours," he told reporters. The former Union minister said the chief minister should stop "drama" and go with him for tests if he was concerned about his health.

Earlier, the SC registry on Wednesday refused an urgent listing of Kejriwal's plea seeking extension of his interim bail by seven days for undergoing the medical tests. He claimed loss of weight and high ketone level.

Kejriwal has asked people not to be sad if anything happens to him in jail or even if he loses his life. He also asserted he was proud of going to jail to save the country from "dictatorship", saying he did not know how long will he remain behind the bars this time. He also appealed to the people of Delhi to pray for his elderly parents.
