Along with that, Sardar Bhuvan's khacho was proposed to be made one way. Later shops will be opened with conditional permission to break illegal pressures and follow necessary SOPs, but sealed complexes will not open here. At present there are about 120 shops apart from the complex which are sealed and will follow the rules. Also

A young man living in a rented house in Bhayli area of ??the city had a desire to go for further studies abroad, but having lost the umbrella of his parents, the financial condition of this young man was not good, so he committed suicide by hanging himself. The taluka police have started an investigation into the incident.

Originally from Umreth village According to the information received, 24-yearold Vishre Rameshchandra Patel, a resident of Purushottam bungalow in Umreth village of Anand district, was living on rent in C-303, Krishna Meridian, next to Era International School in Bhayli of the city for the last eight months. Who ended his life by hanging himself with his T-shirt between 4 pm and 8 pm on Wednesday.

Amit Kumar Rathore among other room partners living in the rented house

along with Vishre Patel who lived in the rented house, came to the room in the evening and woke up to see Vishre Patel in a trapped condition. Meanwhile, he reported the incident to the taluka police and the police came running. investigation was started after taking possession of the dead body. On the other hand, following this incident, the people of the flat as well as the local people came running.

This created a stir in the area. Wanted to go to Germany According to preliminary investigation by the police, Vishre Patel, who committed suicide, was working in a private company and was also preparing to go to Germany for further studies in MS (Master of Science), but due to poor financial conditions, he decided to go abroad for action regarding this incident.

further studies. He used to be confused as the cost was high. The police got the details that Vishcher had cut short his life by hanging himself in his room on Wednesday afternoon as he felt that his dream of studying abroad could not be fulfilled.

The family members rushed to the head constable Ranjit Singh of Taluka Police Station who was investigating the incident and took possession of the body and sent it to Sayaji Hospital for postmortem. Along with that, family members including sister rushed to Vadodara informing their family members. The taluka police have registered a case of suicide and are taking action.

A quarrel with his wife In addition, 31-year-old Jaikishan Chandubhai Chauhan, living in Halol Gokulnagar society in Narmada canal passing by Khandiwala village of Vadodara district, committed suicide after a quarrel with his wife. Jaikishan left home on 3rd and dumped himself in the Kandiwala Narmada Canal. His body was found after he went missing in the canal water. Jarod police have taken possession of the body and are taking action regarding this incident. no more 14 children can be accommodated in a 7 seater vehicle

Over the years, the RTO and the school van drivers had an internal agreement, but Navsari RTO held a meeting with the school van drivers and urged them to follow the rules compulsorily. A discussion meeting was organized at Chapra Ground regarding the fact that if they follow the rules, they will have to bear the financial burden. At the same time, concern has also been expressed that the financial burden will increase on the parents and van drivers who are going to follow the rules.

What will be the penalty if the rules are violated?

violates the rules, the vehicle will be detained for the first time, which will have to be released from the court, in which the fine may be equal to the cost of the school van.

The rule is old but not followed till now the van drivers were working in private parsing without getting taxi parsing in which seven seater parsing vehicle can accommodate 14 children below 12 years of age as per

rule and 7 children above 12 years of age as per rule but if RTO If compliance with the rule is made mandatory, the tax and insurance burden of 40,000 to 45,000 per year will be imposed on the vehicle drivers, in addition to the burden of 1,500 rupees per child per month, the parents will have to collect more than 3,000 rupees per month. This is not the case so that the implementation of the RTO rules on the business of the vehicle drivers has created a situation where the drivers have come together in the school today and tried to bring some mediation in this matter.
