

Dialogue is best option to end Ukraine conflict: India

Delegation Hopes To Focus On Global Geopolitical Turmoil

New Delhi: India on Wednesday reiterated that the best option to resolve the Ukraine conflict is dialogue and diplomacy as Prime Minister Narendra Modi travels to Italy to attend the annual summit of G7 grouping that is set to focus on dealing with global geopolitical turmoil. Modi, accompanied by a high-level delegation, will travel to Italy on Thursday to attend an outreach session on the summit on June 14. It will be his first trip abroad after assuming charge as prime minister for the third term.

The G7 summit, to be held in the luxury resort of Borgo Egnazia in Italy's Apulia region from June 13 to 15, is expected to be dominated by the raging war in Ukraine and the conflict in Gaza. "We have always maintained that dialogue and diplomacy is the best option," foreign secretary Vinay Kwatra said at a media briefing when asked what would be India's approach to resolve the Ukraine conflict. He also recalled Modi's statement in Sept 2022 that "today's era is not of war". Kwatra talked about the consequences of the war including its derivative impact on food, fuel and fertiliser availability, challenges to global supply chains and disruptions in the global economy. "We have always been in

the forefront to talk about not just the conflict, the need for dialogue and diplomacy but also the way the conflict is impacting on the priorities and interests of the developing countries," he said. "We have always been at forefront to offer assistance wherever we can to alleviate challenges faced by the Global South because of the conflict, humanitarian assistance to Ukraine and also to the Global South affected by conflict," he said.

The foreign secretary said India will continue to share its perspective with world leaders on the sidelines of the summit and continue to emphasise and underline the importance of dialogue and diplomacy to address the situation. Kwatra said Modi will participate in the Outreach

session along with the other countries on June 14. The session will be focused on issues relating to artificial intelligence, energy, Africa and the Mediterranean. The foreign secretary said the prime minister's participation in the G7 summit would also provide a timely opportunity to follow up on outcomes of the G20 summit held under India's presidency last year and deliberate on issues which are significant for the Global South.

He said India's regular participation at G7 summit points to increasing recognition to New Delhi's efforts to address global challenges. Kwatra said Modi is expected to hold a bilateral meeting with the Prime Minister of Italy Giorgia Meloni.

Owners asleep in nearby houses, 6 goats stolen from Delhi ahead of Eid-ul-Zuha

New Delhi: In the dead of night, three men sneaked into a bylane in Wazirabad, broke a lock of a house and fled with six goats they packed into a small car parked a distance away - leaving the owners facing losses of Rs2lakh and wondering how they will celebrate Eid-ul-Zuha next week.

The heist in the northwest Delhi locality in the early hours of Monday was captured on CCTV cameras, officials said. The six goats, owned by two men, were kept in an empty plot next to their houses with a lock at the entrance. The incident took place when everyone was sleeping. The getaway car could not

make it through the narrow lane, so the three, their faces wrapped up in mufflers, turned back only to return on foot, the CCTV footage showed. They broke the lock at the entrance with a gas cutter, took out the goats one by one and shoved them into the car parked outside the lane. Police were bought two months ago to be sacrificed during Eid-ul-Zuha next week, he said.
