Dialogue is best option to end Ukraine conflict: India

Delegation Hopes To Focus On Global Geopolitical Turmoil

New Delhi: India on Wednesday reiterated that the best option to resolve the Ukraine conflict is dialogue and diplomacy as Prime Minister Narendra Modi travels to Italy to attend the annual summit of G7 grouping that is set to focus on dealing with global geopolitical

Modi, accompanied by a high-level delegation, will travel to Italy on Thursday to attend an outreach session on the summit on June 14. It will be his first trip abroad after assuming charge as prime minister for the third term.

The G7 summit, to be held in the luxury resort of Borgo Egnazia in Italy's Apulia region from June 13 to 15, is expected to be dominated by the raging war in Ukraine and the conflict in Gaza.

"We have always maintained that dialogue and diplomacy is the best option," foreign secretary Kwatra said at a media briefing when asked what would be India's approach to resolve the Ukraine conflict.

He also recalled Modi's statement in Sept 2022 that "today's era is not of war".

Kwatra talked about the consequences of the war including its derivative impact on food, fuel and fertiliser availability, challenges to global supply chains and disruptions in the global econo-

"We have always been in

the forefront to talk about not just the conflict, the need for dialogue and diplomacy but also the way the conflict is impacting on the priorities and interests of the developing countries," he said.

'We have always been at forefront to offer assistance wherever we can to alleviate challenges faced by the Global South because of the conflict, humanitarian assistance to Ukraine and also to the Global South affected by conflict," he said.

The foreign secretary said India will continue to share its perspective with world leaders on the sidelines of the summit and continue to emphasise and underline the importance of dialogue and diplomacy to address the situation.
