## Over 15 private schools protested against sealing of governing bodies

Surat, After the Gozari incident of fire in the game zone in Rajkot, an investigation has been carried out regarding fire safety and sealing action has been taken. Then there was anger among the school administrators who sealed more than 15 private schools in Kapodra and Pune areas. The allegation was met with opposition by the school management. Along with this, it has been alleged that the schools have been sealed despite having a fire NOC. After the incident in Rajkot, the state government has started an investigation regarding fire safety in schools. While all properties and premises are sealed if they do not have this facility, schools are not exempted from this. A meeting was held by Surat Municipal Corporation and Collector yesterday. In which an investigation has been started regarding fire safety in schools as well. The district education officer protested by the governing body has also ordered to submit the inspection report on fire

equipment and electrical appliances in all the schools immediately. Then all the schools which do not have fire NOC are being sealed, this action is taking place for the future of the children. At that time, the private school management is protesting in this matter. Allegation of sealing despite fire NOC in this matter, the district education officer mentioned in his notice that there are many schools in Limbayat, Varachha and Pune areas of Surat which have been started inside small houses. There is no fire safety of any kind and no entry exit. If an accident happens, innocent people can be killed! Today, more than 15 private schools in Pune and Kapodra areas have been sealed. It has been alleged that even private schools have been sealed despite having a fire NOC.

Jagdish Chavda (Gujarat State School Management Board) said that private schools in Pune area have been sealed by Surat Municipal Corporation without

giving any written notice. Which is completely illegal. All our schools are regulated by the municipal by-laws. However, this operation has been done today. He further said that the officials also seal the schools which have NOC to show their performance and compromise the future of the children. The municipality will be solely responsible for educating the children. The governing body of the private schools announced that all schools will remain closed indefinitely until the municipal corporation opens the seal.

The entire responsibility of teaching the children in the session which is going to start on the next 9th will be the responsibility of the Metropolitan Municipality. The fire department of the Surat Municipal Corporation has shown the reason for the COR regarding the sealing operation.

As the impact fee law is in place by the government, our petitions are pending in the matter of impact fee, so COR cannot be considered illegal.

## Office Productivity Takes a Hit in the Afternoon, Particularly on Fridays

A recent interdisciplinary study at the Texas A&M School of Public Health used a novel method of data collection to show that employees really are less active and more prone to mistakes on afternoons and Fridays, with Friday afternoon representing the lowest point of worker productivity. The study, published in the journal PLOS ONE, was authored by Drs. Taehyun Roh and Nishat Tasnim Hasan from the Department of Epidemiology and Biostatistics, along with Drs. Chukwuemeka Esononu, Joseph Hendricks, and Mark Benden from the Department of Environmental and Occupational Health, and graduate student Anisha Aggarwal from the Department of Health Behavior. The researchers looked at the computer usage metrics of 789 in-office employees at a large energy company in Texas over a two-year period — January 1, 2017, to December 31, 2018. "Most studies of worker productivity use employee self-reports, supervisory evaluations, or wearable technology, but these can be subjective and invasive," said Benden, professor and head of



the Department of Environmental and Occupational Health. "Instead, we used computer usage metrics — things like typing speed, typing errors and mouse activity — to get objective, noninvasive data on computer work patterns." The team then compared computer usage patterns across different days of the week and times of the day to see what kinds of patterns emerged. "We found that computer use increased during the week, then dropped significantly on Fridays," said Roh, assistant professor in the Department of Epidemiology and Biostatistics. "People typed more words and had more mouse movement, mouse

clicks and scrolls every day from Monday through Thursday, then less of this activity on Friday." In addition, Roh said, computer use decreased every afternoon, and especially on Friday afternoons. "Employees were less active in the afternoons and made more typos in the afternoons—especially on Fridays," he said. "This aligns with similar findings that the number of tasks workers complete increases steadily from Monday through Wednesday, then decreases on Thursday and Friday." What is the takeaway for employers? To start, flexible work arrangements, such as hybrid work or a four-day work week, may lead to happier and more productive employees. As of May 2023, about 60 percent of full-time, paid workers in the United States worked entirely on-site. The remainder either worked remotely or had a hybrid arrangement that involved a combination of remote and on-site work. In addition, many employees have a compressed workweek in which they work longer hours, but on fewer days. "Other studies have found that those who work from home or work fewer days have less stress from commuting, workplace politics and other factors, and thus have more job satisfaction," Benden said. "These arrangements give workers more time with their families and thus reduce work-family conflicts, and also give them more time for exercise and leisure activities, which have been shown to improve both physical and mental health." The Meteorological Department had earlier predicted that the temperature would rise as the clouds cleared from across the state, following which a heat wave alert has been issued in the state for the next 5 days today. Ramashray Yadav, a scientist of the Meteorological Department, said that the heat will remain unchanged in Gujarat for 7 days and there is a possibility of one-two degree increase. Today, Ahmedabad, Rajkot, Disa recorded a temperature of 44 degrees, while Bhavnagar, Surendranagar, Porbandar, Junagadh and Valsad have declared yellow alert for 5 days.

Announcing orange alert in Ahmedabad for 48 hours, he further said that a total of three districts in the state recorded maximum temperature of more than 44 degree Celsius yesterday, meaning the scorching heat in three districts forced people to cry Trahi Maam. Surendranagar district recorded the highest temperature of 44.8 degrees Celsius yesterday in the state. Apart from this, Ahmedabad and Gandhinagar recorded a temperature of 44.2 degrees Celsius. However, Orange Alert was declared in Ahmedabad for the next 48 hours by the Meteorological Department. Temperature of Ahmedabad recorded 44.2 degree Celsius. The maximum temperature of this year was recorded in Ahmedabad city at 44.2 degree Celsius. Due to the sudden increase in the maximum temperature, the urban residents cried out. Today, the city dwellers had to bask in the heat, as the sky will experience ember rain from 3 pm to 7 pm. The temperature may increase by 1-2 degrees. Heatwave alert



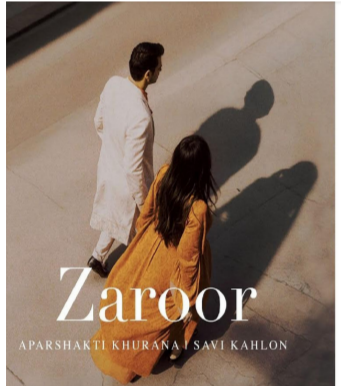
