ormer India captain Sourav Sourav Ganguly on Saturday said Gautam Gambhir would be a "good coach" for the national cricket team if he has applied for the job as his "hunger and passion" was evident in the recently-concluded IPL.

Speaking at the inauguration International Procurement and Supply Chain Conference organised the Blue Ocean Corporation, Ganguly also gave his views on India's chances in the upcoming T20 World Cup.

The former BCCI President said he is in favour of the national team having an Indian coach since there is enough talent in the country.

"I am in favour of an Indian coach because we have enormous talent in our country, enormously highskilled players who have done wonders for Indian cricket and very rightfully they should be a part of the system," Ganguly

On whether the widely

Gambhir would be suitable for the position, Ganguly had a query of his own at first.

... Has he applied? I really don't know because first he has to apply and then only he will get the job...I think (May) 27th was the last date of application," Ganguly said.

Obviously, BCCI has the right to extend it (the deadline) as well. If he applies and if he wants it, and I say if he applies and if he wants it, he will be a very good candidate," he said. 51-year-old Gambhir's winning attitude as IPL champion Kolkata Knight Riders' mentor was there for all to see this year.

"If Gambhir applies — you can see it on TV — he worked for KKR this year. I was with Delhi (Capitals), you can see the hunger, the passion and the want to win and I will be happy if he applies and if the board decides to give him the job, I think he is a good candidate," Ganguly said. Ganguly said India are superior to Pakistan but the arch-rivals will pose a tough challenge in the T20 format when the two sides clash on

Our record against Pakistan has been very, very good over a long period of time. In the T20 format, probably Pakistan is more dangerous compared to 50-overs (format). We beat them in Ahmedabad when they came to India and we beat them easily.

"India is superior and if they play well, if they play freely and I keep saying the word 'freely' all the time because (in) the last World Cup in Australia, I don't think we played freely," he said.

Just put all the cobwebs behind. Don't worry about winning or losing. Don't think about winning the World Cup. Just go and play every game,"



I don't try to over-teach: Bumrah on mentoring India's young pacers

onsidered a mentor for the Cnew crop of Indian fast bowlers, pace spearhead Jasprit Bumrah says he never tries to "over-teach" the younger lot and steps in to help only when asked, to avoid burdening them with information.

The 30-year-old Bumrah would be a key player for India in the T20 World Cup, starting here on Saturday and he would also be expected to be a guiding force for India's pace battery, featuring the relatively younger and less experienced Mohammed Sirai Arshdeep Singh.

"You don't try to over-teach. That is something that I have learned," Bumrah told the ICC's official website for the T20 World Cup.

"Because whenever people need help, I let them have their own questions... Because you don't want to give too much information," he said.

Bumrah said it is important for youngsters to know their path without being burdened with an overkill of information. "It's not like they have just been

lucky and they land here. So that is what I try to do. I do pass on certain information that I have gained over from my experience," he said. "But I don't try to burden them

with (over) information. Because that is a part of the journey as well. That you have to find your own ways and solutions," he added.

Bumrah has battled a nagging back injury for the past couple of years and it even kept him out of the 2022 T20 World Cup but he has managed to fight through and enjoyed a brilliant run in the 2023 ODI showpiece.

He snared 20 wickets at an average of 18.65 with an economy of just about four in
