# **Class VI boy crushed** to death by tiller attached with tractor

In a ghastly accident, a 14-yearold was crushed to death after getting trapped in a tiller attached to a tractor in Simrol police circle around 11 am on Tuesday. The incident was so horrific that the boy's head and chest were ripped open and he died on the spot.

According to the police, the deceased was identified as Prince son of ManojJhariya, a resident of Chikhli Village. The deceased's uncle Ajay Jhariva said that Prince was a student of VI standard. He was at home when he received a call from his friend that plowing work in the field was going on and asked him to come to the field. The incident occurred when a youth was plowing a field with a



tractor and the deceased attempted to sit on the tractor. He lost his balance and fell on the ground coming underneath the tiller and it crushed him to death. His father is a farmer. He was the only son of his parents and had two vounger sisters.

The police initiated an investigation into the case to ascertain the reason surrounding the incident.
