Odisha: Wildlife criminal sentenced to 3 years RI for trading leopard skin

Bhubaneswar, (UNI) The Sub-Divisional Judicial Magistrate, Baragarh on Saturday convicted an accused under section 51 of Wildlife Protection Act, and sentenced him to three years rigorous imprison-

The court also imposed a fine of Rs.10,000 on the convict for commission of offence under section 51 of The Wild Life (Protection) Act, 1972

According to the prosecution, one Satyaban Sahu, wildlife criminal of Khajuria village under Bargarh district, was apprehended by the STF of Bhubaneswar on November 24, 2020 and leopard skin along with other wildlife products, was recovered from his posses

Sahu was nabbed while waiting at a place to deliver the leopard skin to a cus-

After successful investigation, a chargesheet was submitted against the accused persons under section 379/411/120-B IPC r/w. 51 of Wild Life Protection Act. 1972.

During investigation the seized Leopard skin was also sent to WildLife Institute of India, Dehradun for biological chemical examination and opinion was received affirmatively.

The trial was conducted against the accused person and the judge after examining 12 witnesses including the Scientific Officer of WLI Dehradun, convicted the accused.

This is the fifth case of STF where the accused under Wildlife Protection

The conviction rate of vildlife crime cases in In dia is less than five per cent. However,the STF Odisha has taken special efforts to ensure that the investigation is of the highest standards so that the cases are brought to logical conclusion/conviction STF is the specialized wing of Odisha Police to curb the organized crime as well as cases against wild-

The STF had the power/ authority to investigate wildlife cases in 2018. So far, STF has detected 100 cases and have arrested 232 wild life Criminals.

Among the seizures, the STF had so far seized 58 leopard hides 27 elephant tusks, 23 life pangolin, 42 Pangolin scales, two tiger hides and eleven deer

Jharsuguda Faces Severe Water Crisis Amid Scorching Heat

Jharsuguda, (TNB): The water supply situation in Jharsuguda has become dire as temperatures soar to 44 to 47 degrees Celsius. Residents are struggling to access potable water due to a significant drop in the water table. Despite efforts by the Water Corporation of Odisha (WATCO), the supply remains inconsistent and inadequate.

WATCO constructed three underground and overhead reservoirs to store and distribute water across Jharsuguda. Water distribution commenced two days before the recen has been erratic since May 21. In areas such as Cox Colony, Shital Colony, and Babua Baghicha, water is available for only 10 min utes in the morning and is completely shut off in the

Attempts to resolve the ssue have been met with unresponsiveness from local officials. Kishore Kumar Kandi, the Junior Engineer in charge, has not been available for comment, and linemen claim they are powerless to address the prob-



lem, urging residents to contact the main office.

Subrata Kumar Naik, the Public Health Department Engineer and WATCO Secretary, is reportedly too oc-

cupied with duties in Rourkela to address the crisis in Jharsuguda. Despite being informed of the situation, he has expressed regret but taken no action

The water supply project Health Department and approved by the Chief Minister in 2013, was handed to Megha Engineering Infra-structure Limited. Though construction began in No-vember 2017 and was scheduled for completion by November 2020, delays pushed the completion to 2024. However, the project has yet to deliver reliable water supply to the city.

Residents are calling for an investigation by the district committee to address the intricacies and ensure a consistent water supply in Jharsuguda
