Biden pushes for truce, says Hamas incapable of attacking Israel again

WASHINGTON

US President Joe Biden on Friday detailed a threephase deal proposed by Israel to Hamas militants that he says would lead to the release of the remaining hostages in Gaza and could end the grinding, nearly 8-month-old Mideast war. Biden added that Hamas is "no longer capable" of carrying out another large-scale attack on Israel as he urged Israelis and Hamas to come to a deal to release the remaining hostages for an extended cease-fire.The Democratic president in remarks from the White House called the proposal "a road map to an enduring cease-fire and the release of all hostages".

Biden said the first phase of the proposed deal would would last for six weeks and would include a "full and complete ceasefire", a withdrawal of Israeli forces from all densely populated areas of Gaza and the release of a
