ECI seeks action against IPS officer

BHUBANESWAR: The Election Commission of India (ECI) has recommended action against Odisha's IPS officer Ashish Kumar Singh for 'misrepresentation of fact' about his health condition while revoking the suspension order on another senior police officer D S Kutey. In a letter to the Chief Electoral Officer (CEO) of Odisha, the ECI said the report of the special medical board of AIIMS, Bhubaneswar, has declared Singh, a 2010 batch IPS officer, physically and mentally fit.

FAMILY FEUD TURNS UGLY

Fans of Kannada star Shivarajkumar storm BJP leader's house

BENGALURU: A family feud turned ugly on Saturday as fans of Kannada superstar Dr. Shivarajkumar stormed the residence of senior BJP leader Kumar Bangarappa in Bengaluru over some derogatory comments he posted on Facebook.

Police quickly arrived at the scene, detaining the protestors and pursuing those who attempted to flee.

Irked by this, the protestors forcefully entered the leader's residence chanting slogans against Kumar Bangarappa.

In response, a platoon of the Karnataka State Reserve Police (KSRP) was deployed to prevent further incidents. Shivarajkumar's wife, Geetha Shivarajkumar, who is Kumar Bangarappa's sister, ran against BJP candidate BY Raghavendra on the Shivamogga Lok Sabha seat as a Congress candidate. Raghavendra won the Shivamogga Lok Sabha seat by a comfortable margin of 2.43 lakh votes.

Kumar Bangarappa, who is close to former Chief Minister, BS Yediyurappa's family had campaigned for Raghavendra.

After his sister Geetha's defeat, Kumar Bangarappa put up a post on Facebook, criticising her for 'misusing' their late father, former CM S

Pandian not my successor...: Naveen Patnaik

Days after the results of the Odisha assembly polls, state outgoing Chief Minister Naveen Patnaik on Saturday said that Biju Janata Dal (BJD) leader VK Pandian is not his "successor" and pointed out that the people of the state would decide on this. Pandian, an IAS officer of the 2000 batch, has served as private secretary to Patnaik for over two decades. In 2023, he joined the BJD after taking voluntary retirement from the bureaucracy.

In a conversation with reporters in Odisha's Bhubaneswar, Patnaik said, "I would like to say that Mr Pandian has also worked and helped in health, education, sports, and our programme of temple restoration. Mr Pandian joined the party but has not had any posts. I have always clearly said that when they asked me about my successor, I said clearly that it was not Mr Pandian. I repeat it. The people of Odisha will decide my successor."

Surekha Yadav, the pilot of the Chhatrapati Shivaji Maharaj Terminus-Solapur Vande Bharat train in Maharashtra, is among 10 loco pilots of the Indian Railways who have also been invited to the ceremony.

Necessary arrangements have been made for the guests, including designated enclosures for the council of ministers to be sworn in and the VVIPs, the officials said on Saturday.

The Rashtrapati Bhavan shared a video of the preparation for the grand ceremony which showed a large number of chairs being arranged and covered with white cloth and the laying of a red carpet.

The leaders of regional grouping SAARC (South Asian Association for Regional Cooperation) countries attended Modi's first swearing-in ceremony when he took the reins as the prime minister after a massive electoral victory for the BJP in 2014.

PROSTATE CANCER AWARENESS: UNDERSTANDING THE BASICS

Q: What is prostate cancer?

ACTIVE SURVEILLANCE: For low-risk cases, monitoring the cancer closely with regular tests.

SURGERY: A radical prostatectomy involves removing the prostate gland.

RADIATION THERAPY: External beam radiation or brachytherapy to target cancer cells.

HORMONE THERAPY: Reduces levels of male hormones that can fuel cancer growth.

CHEMOTHERAPY: Used in advanced stages to kill cancer cells.

TARGETED THERAPY AND IMMUNOTHERAPY: Newer treatments that attack specific cancer cells or boost the immune system.

Woman brutally beats up baby, sends video to husband; arrested

ALAPPUZHA: A woman was arrested for allegedly beating up her one-year-old child brutally and sending the video of the act to her estranged husband in Kerala's Alappuzha district, police said on Saturday.

In the purported video, the woman could be seen hitting the child repeatedly and saying "watch this and enjoy".
