

Rally to oppose Shaktipeeth highway planned on June 18

Kolhapur: State gov't on Monday announced land acquisition notification for the Shaktipeeth highway from Pannar to Patradevi despite opposition to the project from various quarters.

A 21-day time has been given to raise objections, if any, to the highway.

The Shaktipeeth highway of 802km will be of six lanes. It will pass through 12 districts of the state - Wardha, Yavatmal, Hingoli, Nanded, Parbhani, Beed, Latur, Dharswad, Solapur, Sangli, Kolhapur and Sindhudurg. There will be interchanges at 26 places on the highway. There will be 48 major bridges, 30 tunnels, and eight railway crossings.

Land from 59 villages in Kolhapur district and 16 villages from Sangli district will be acquired for the highway.

Former MP Sanjay Mandlik, former MP Raju Shetti, MLC Satej Patil, MLA Prakash Abitkar, guardian

minister Hasan Mushrif and BJP district office-bearer Samarjeet Ghatge have demanded cancellation of the highway.

An all-party massive protest rally has been planned on June 18 in front of district collectorate in Kolhapur to oppose the 802-km highway project. Former MP Sanjay Mandlik and Radhanagar assembly constituency MLA Prakash Abitkar met chief minister Eknath Shinde in Mumbai on Wednesday demanding cancellation of the highway. Earlier on Tuesday, district office-bearer of BJP and chairman of Shahu Sugar factory, Samarjeet Ghatge, met chief minister Eknath Shinde on Tuesday demanding cancellation of the highway.

As many as 59 villages in Kolhapur district will be affected due to the Shaktipeeth highway. The highest number of 21 villages are in Bhudargad tahsil, 13 villages in Kagal tahsil, 10 in Karvir tahsil and five each in Shiroli, Hatkanangle and Ajara tahsils.

Guardian minister Hasan Mushrif said, "The highway will pass through nearly 60 villages from the district due to which many farmers will become landless. This scenario has been brought to notice of chief minister Eknath Shinde and deputy chief minister Ajit Pawar. The highway is one of the major reasons for resentment and anger among farmers, resulting in the defeat of Mahayuti candidate in the recently concluded Lok Sabha elections. This highway should be cancelled at any cost and we don't want any alternate route."

The state government will spend Rs 86,000 crore for the Shaktipeeth highway and the work is proposed to start from next year, with a deadline for completion in five years.

The Shaktipeeth Highway Sheti Bachao Kruti Samiti from Sangli district have called a meeting on June 13 at Daulat office in Sangli city to decide on the further action of action to oppose the highway.

Green light to ₹134 crore for laying drainage lines

Kolhapur: The principal secretary of the state urban development department has given administrative approval for clearing funds worth Rs134 crore under govt's Amrut-II scheme to lay drainage lines, construct substations and more in the Bapat Camp area.

A meeting was held in Mumbai on Tuesday with the principal secretary, attended online mode by various Kolhapur Municipal Corporation (KMC) senior officials.

With these funds, drainage networks will be created in the eastern suburbs of Kolhapur city, to be collected in the Bapat Camp and then diverted to an STP in Kasba Bawda. At least 15 million litres per day (MLD) of sewage will be treated to reduce pollution of the Panchaganga river.

KMC city engineer Netra-deep Sarnobat said, "Earlier, drainage line works were done for in Kolhapur city in the Duhali and Jayanti nullah areas from funds received under the Amrit-I scheme, and from central govt's development fund for medium and small cities. However, the eastern suburb of the city was deprived of drainage lines for many years."

He added, "Now, drainage line networks will be constructed from Tararani Chowk to Market Yard, as well as in Temblaiwadi, Vikramnagar, Kadamwadi, Bhosalewadi and adjoining areas." He added that the scheme's administrative nod was delayed due to the election model code of conduct.

MSEDCL joint MD tells staff to fix frequent power cut issues

Says Action Will Be Taken If Problem Persists

Chhatrapati Sambhajinagar: As frequent power cuts continue to trouble consumers across Chhatrapati Sambhajinagar, MSEDCL joint managing director Rahul Gupta on Wednesday warned the staff of stringent action if the problem persists.

The official also said that existing power transformers and distribution network in vulnerable areas will be augmented for handling additional power load.

"Officials and staff were earlier asked to pull up their socks with an aim to provide smooth service. We have already taken action against a few officials for not being prompt. With no desired improvement in the situation we are left with no option but to punish errant workforce within the available legal frameworks," he said.

Gupta said an inspection of areas facing frequent power cuts will be also ordered. "We have carried out similar exercise in the past at few localities. Based on the feedback from the consumers, we

will carry out large scale inspection," he said.

The top-boss of the state power utility for Marathwada said efforts are being taken to seek benefits of the Revamped Distribution Sector Scheme (RDSS) for increasing power sub-stations and developing other infrastructure solutions. "Certain procedural time is required for drawing the benefits of the RDSS. We have already sent the necessary proposals," he said.

Meanwhile, the MSEDCL authorities said they are gearing up to install smart meters by replacing the existing ones as part of the state-level drive with offices of the state power utility and other government establishments to get covered first.
