# IMC to restart green waste compost plant at Sirpur Lake

A green waste compost plant lying idle at Sirpur Lake should be restarted. These instructions were given by municipal commissioner Shivam Verma during his inspection on Saturday. He also instructed IMC officials to remove the encroachment made on the drain situated in Jagdish Puri Colony. Commissioner Verma inspected the garbage treatment/transfer stations and drains situated in Sirpur area along with the clean-



ness in the premises. While inspecting the Jagdish Puri drain the commissioner found that several encroachments have been done on the drain thus obstructing the overflow of water from the Sirpur Lake. The commissioner instructed that the encroachments should be demolished.

# Future of agricultural development discussed

Indore: The eighth five-year review meeting took place at Agricultural College, bringing together a diverse group of stakeholders to discuss the future of agricultural development. The event was chaired by Punjab Singh, chairman of the high-powered committee, and attended by committee members P. Ram Sundaram, B.M. Bhale, and Indramani from Parbhani, Maharashtra, along with representatives from Nagpur and Bhubaneswar. During the meeting, attendees shared information about their respective departments and discussed plans to work collaboratively for the welfare of farmers. Bhupendra Dharwa emphasized the importance of supporting farmers in the production of pulses, oilseeds, soybeans, and wheat. He called for an awareness campaign to ensure research information reaches the maximum number of farmers.

# Youth Cong prez alleges Mayor responsible for IMC scam

He demands resignation of former Mayor and MLA Malini Gaud as well

MP Youth Congress president Mitendra Singh Yadav levelled serious allegations against Indore Mayor Pushyamitra Bhargav, accusing him of being responsible for the fake bill scam exceeding Rs 100 crore within Indore Municipal Corporation (IMC). Yadav claimed that Bhargav, who also chairs the corporation's finance and taxation committee, disbursed large sums to contractors for work that was never performed. He further implicated former Mayor, MLA Malini Gaur, demanding her resignation over her alleged complicity in the scandal. He criticised Bhargav, stat-

ing, "The mayor wants to make Indore number one in scams too. This scam has also tarnished Indore's image as the cleanest city." The Youth Congress president also pointed to a related scandal involving nursing colleges, which he compared to the infamous VYAPAM scam. He alleged that the BJP government's 20-year rule has jeopardised the future of youths enrolled in these sub-standard institutions. Yadav implicated former medical education minister Vishwas Sarang, asserting his awareness and responsibility in permitting unsuitable nursing colleges. Additionally, Yadav highlighted discrepancies in Jal Mission awards in Burhanpur, where he claimed officers reported false figures, with many areas still lacking water supply. He pointed out that in Kolki village, despite laying a pipeline, taps have not been installed, forcing residents and animals to share pond water. Yadav submitted a memorandum to senior police officials addressing increasing crime rates, assaults on media personnel and the negative impact of city's night culture.

# Farmers to intensify protest against land acquisition

Hundreds of farmers, whose lands have been marked for acquisition for the Indore-Budhni railway line and outer ring road Indore, have resolved to intensify their protests against land acquisition in Sanwer town of Indore district. In a resolute stand against what they perceive as a betrayal of trust by the government, farmers from various backgrounds gathered at Farashpur and decried the government's failure to fulfill its commitments. As per farmers, MPs and MLAs have been prioritizing their interests over the welfare of the farming community. Former janpad member and farmer leader

Hansraj Mandloi, alongside former Farashpur gram panchayat sarpanch Mukesh Tiwari also attended the meeting. Sanwer janpad panchayat vice-president and outer ring road affected farmer Anokhila Patel asserted their resilience against government pressure. Farmer leader Mahesh Patel said that farmers have been enduring extreme weather for 8 months, but to no avail. He urged caution in trusting any political entity moving forward. In a unified decision, farmer leaders pledged to visit affected villages, vowing to resist land acquisition. Vishnu Prasad Patel, Ramdulare Chaudhary, and other protestors threatened a massive agitation after June 4.
