## **Hooda: Congress will** keep raising demand for Ahir regiment in Army

FORMER HARYANA chief minister Bhupinder Singh Hooda Saturday said the Congress will keep raising at every platform the demand for the creation of an Ahir regiment in the Indian Army. He said if the Congress forms the government in Haryana after the upcoming Assembly elections, a proposal will also be sent to the Centre in this regard.

"The Ahir regiment is not just the demand of south Harvana but the entire country," the Congress leader said. The Ahirwal belt (Rewari-Gurugram-Mahendragarh) is known for its contribution to the defence forces. Hooda was in Rewari to address the Congress workers' conference to thank them for their efforts during the Lok Sabha elections. He was accompanied by Haryana Congress president Chaudhary Udaibhan, former MLA Ajay Singh Yadav, Congress leader Raj Babbar, MLA Chiranjiv Rao and many senior party leaders.

Hooda said south Haryana received many gifts like Rewari-Rohtak railway line and NH-71 during the previous Congress government. "The Congress had taken steps to make south Harvana a hub of education by establishing institutions like Central University Mahendragarh, Indira Gandhi University Mirpur and Sainik School." said the Leader of Opposition in the Haryana assembly. "During our government, the defence university was also approved here, but as soon as the BJP came to power, it shelved the project.

Along with this, this govern-

ment also destroyed the expansion of the education sector and infrastructure. The BIP has cheated the entire Haryana, including Ahirwal by taking votes," he alleged. "This is the reason why Haryana, which was the number one state in the country in per capita income, per capita investment, employment, sportspersons and welfare schemes till 2014, has been made number one by BJP in unemployment, crime, drug addic-

tion and misery," he said. He accused the BJP government of abolishing permanent jobs and implementing exploitative policies like Kaushal Nigam, in which there is no permanent job for the youth, no post, no promotion, no merit, transparency and reservation. "Through such policies, the BJP is ending the reservation of the Scheduled Castes (SCs) and Other Backward

Hooda said once the Congress forms the government in Haryana, every elderly person will be given Rs 6,000 pension and the employees will be given the old pension scheme.

Classes (OBCs)," he said.

"To give relief to people from inflation, 300 units of free electricity and gas cylinders will be given for Rs 500. To curb unemployment, transparent recruitment will be done on the basis of merit according to qualification for two lakh vacant posts," he said.

"The scheme of giving free plots of 100 square yards to the poor, the SCs and the OBC families and building a two-room house on it will be started again. Also, to give full benefit of reservation to the backward class, the limit of creamy layer will be increased from eight to 10 lakh," he added.

### BJP leaders slam Sukhu for skipping Niti Aayog meeting

Shimla: The BJP Saturday hit out at Chief Minister Sukhvinder Singh Sukhu for not attending the Niti Aayog meeting, despite being present in Delhi. Leader of Opposition (LoP) Jai Ram Thakur accused CM of indulging in petty politics instead of giving preference to the interests of Himachal Pradesh.

"CM Sukhu went to Delhi but did not attend Niti Aayog meeting. He should have attended it for the sake of Himachal Pradesh. INDIA Bloc decided to boycott the meeting but Sukhu should have given priority to the

## Sarabjeet to meet Shah today: 'will seek Amritpal's release'

**RAAKHIJAGGA** LUDHIANA, JULY 27

FARIDKOT MP Sarabjeet Singh Khalsa said that he would meet Union Home Minister Amit Shah in New Delhi on Sunday, demanding the release of Khadoor Sahib MP Amritpal Singh and other Sikh prisoners who are yet to be released despite completing their terms.

Pro-Khalistan radical preacher and Waris Punjab De (WPD) chief Amritpal is currently lodged in Assam's Dibrugarh jail, along with nine associates, under the National Security Act (NSA).

"Khalsa was speaking at Gurdwara Sri Reru Sahib in the Sahnewal constituency, Ludhiana district, on Saturday afternoon at a programme organised to honour him and Tarsem Singhji, the father of Amritpal Singh," said Santa Singh Umaidpuri of the Shiromani Akali Dal (Sudhar Lehar) (the rebel faction).

Khalsa, son of Beant Singh, one of the assassins of the late Prime Minister Indira Gandhi, said, "Union Home Minister Amit Shah has given me time on Sunday during which I will raise three main issues — the release of Amritpal Singh and other Sikh prisoners languishing in jails even after completing their jail

terms; legal guarantee on MSP should be introduced in the country and protesting farmers should be heard; and, jobs should be provided to a family member of farmers died during the Kisan aandolan 1 and 2.0."

"In addition to these, we want punishment in the sacrilege cases should be life term instead of only three years, as of now," he said.

Commenting on Khalsa's recent remarks that "there was a need to create a new panthic outfit", Tarsem Singh said, "We need to bring like-minded Panthic organisations on a common platform and have thorough discussions before arriving

at a conclusion about floating a new outfit."

Sukhwinder Singh, nephew of Satwant Singh, one of the assassins of former Prime Minister Indira Gandhi, said. "We are thankful to the sangat for voting for Khalsaji and Amritpal Singh this Lok Sabha elections. Sikh Panth needs direction, and hence, we are now having two representatives among us. We must strengthen their movement. I need to tell you that the Shiromani Akali Dal is an organisation made of sacrifices and it is not one person's party. Now, we need to take part in the SGPC polls to choose the right candidates."
