
On 13 July 2018, CRPF troops from the 96th Battalion were on law and

The surprise attack involved indiscriminate firing, to which the troops couldn't respond immediately due to the risk of collateral damage. Constable Bhopal Singh, Constable Nrapendra Kumar, and Constable K. Shankaran sustained bullet injuries.

Two succumbed to their injuries on the same day, and the third passed away on 2nd August 1989. All three bravehearts were martyred in the line of duty. The nation will forever remain indebted to them and their families.
