CLOONEY, DOUGLAS, PELOSI URGE JOE BIDEN TO DROP OUT

WASHINGTON

US President Joe Biden was left reeling on Wednesday when actor and leading Democratic supporter George Clooney urged him to drop his reelection bid, while party heavyweight Nancy Pelosi declined to back his candidacy.

As the 81-year-old tried to show his leadership credentials at a NATO summit in Washington, domestic pressure mounted on Biden to quit following his disastrous debate performance against Republican challenger Donald Trump.

Biden has been trying to stem a growing tide of Democrats saying that he cannot win in November, but Clooney's surprise intervention squashed efforts to turn the page on the crisis. The Hollywood star penned a devastating editorial in the *New York Times* just three weeks after co-hosting a huge fundraiser in Los Angeles that raised nearly \$30 million for Biden.

"It's devastating to say it, but the Joe Biden I was with three weeks ago at the fundraiser was not the Joe 'big F-ing deal' Biden of 2010," wrote Clooney.

"He wasn't even the Joe Biden of 2020. He was the same man we all witnessed at the debate." Clooney said that Biden would lose the presidential election, and Democrats would also lose both chambers of Congress. At the June 15 fundraiser in Los Angeles co-hosted by Clooney and fellow movie star Julia Roberts, Biden appeared tired as he took to the stage alongside former president Barack Obama.

He had flown straight to California from the G7 summit in Italy and has since blamed jetlag, and a cold, for his disastrous performance in the June 27 television debate with Donald Trump.

Fellow actor Michael Douglas followed up Wednesday, saying he was "deeply, deeply" concerned about Biden's prospects. In response to Clooney's editorial, the Biden campaign pointed to the president's statements on Monday saying he was "committed" to running again in November. Media-shy for much of his presidency, Biden will also give a fresh interview, to broadcaster NBC on Monday. as he seeks to convince voters.

The president Joe Biden on Thursday will give his first press conference since his debate disaster against Donald Trump, in a make-or-break moment for the fate of his teetering reelection bid.

But while top Democrats broadly but unenthusiastically backed him on Tuesday, Biden's efforts to stop the bleeding increasingly looked to be in vain. *AFP*

Kenyan prez dismisses cabinet ministers

Nairobi: Kenyan President William Ruto on Thursday dismissed almost all of his Cabinet ministers and promised to form a new government that will be lean and efficient following weeks of protests over high taxes and poor governance. The president also dismissed the attorney general and said ministries will be run by their permanent secretaries. Ruto said he made the decision after listening to the people and he would form a government after consultations.

Imran mirrored terrorist action, says Pak court

Lahore: An anti-terrorism court in Pakistan on Thursday said the actions of jailed former prime minister Imran Khan were similar to that of a "terrorist" in a case linked to the May 9 violence and ruled that he had delegated the task of attacking military installations, government properties, and police officials to party leaders to exert pressure for his release. The 71-year-old PTI founder and hundreds of his party colleagues are being tried under multiple cases.

EX-MINISTER JAILED 10 YEARS FOR GRAFT



Former agriculture minister was jailed for 10 years on Thursday after he was found guilty of misappropriating public funds. Syahrul Yasin Limpo was found guilty by a Jakarta court of ordering officials in his ministry to send him money from state coffers, some of

which was used for his personal expenses. "The defendant ... was legally and convincingly proven according to the law to be guilty of committing a criminal act of corruption," said presiding judge Rianto Adam Pontoh. Judges found he had spent more than **AFP** \$900,000 on personal expenses.

WORKERS **ARRESTED**

Immigration authorities have arrested 88 foreigners, including 64 Thais, in a crackdown on sex activities at three locations in Ipoh city, *Bangkok Post*. The crackdown took place at a hotel and two entertainment venues suspected of offering sex services on Tuesday and Wednesday. The detainees were 78 women and 10 men.

A total of 27 people, aged between 24 and 77, are under investigation for the peddling and possession of smokeless tobacco products in Little India, *The* Straits Times reported.
