All-party meet: Opposition raises Kanwar eatery order, NEET rows

GOVT SEEKS COOPERATION FOR SMOOTH RUNNING OF PARLIAMENT

Opposition parties drew the battle lines on the eve of Parliament's Budget session on Sunday as they asked the government at an all-party meeting to allow discussion on a host of contentious issues such as the Uttar Pradesh government's order to eateries on the Kanwar Yatra route and exam paper leaks, including of the prestigious NEET.

The government, which breaking from the recent practice invited a number of smaller parties for the meeting to signal its political outreach, conveyed its willingness to discuss all issues but Parliamentary Affairs Minister Kiren Rijiju stressed that it should be in accordance with the rules.

He called for cooperation from all parties for running Parliament smoothly, saying it is a collective responsibility. Chairing the meeting, Defence Minister Rajnath Singh spoke against disruptions in Parliament and said its sanctity must be maintained.

Special category status for Bihar, AP and Odisha demanded

NEW DELHI: Ahead of the Budget session of Parliament, the JD(U), YSRCP and BJD on Sunday demanded special category status for Bihar, Andhra Pradesh and Odisha respectively, while the Congress's Jairam Ramesh said "strangely, the TDP kept quiet on the matter".

The demand for special category status for Bihar during an all-party meeting came from the ruling NDA as well as the INDIA opposition bloc, with BJP allies -- Sanjay Kumar Jha of the Janata Dal (United) and Union minister Chirag Paswan of the Lok Janshakti Party (Ram Vilas) -- also batting for it. The Rashtriya Janata Dal (RJD) also joined the chorus.

Jha, however, said a special financial package can also be an option if a special status is not possible.

Ramesh said the JD(U) and the YSRCP demanded special category status for

was joined by other INDIA bloc members in seeking the Lok Sabha deputy speaker's position for the opposition according to convention.

He said they also flagged the need for discussion in Parliament on a host of other issues, including the spate in

Bihar and Andhra Pradesh respectively but "strangely", the ruling Telugu Desam Party (TDP) in the southern state kept quiet on the matter.

In a post on X, the Congress leader, who was present at the meeting, said, "In today's all-party meeting of floor leaders chaired by Defence Minister Rajnath Singh, the JD(U) leader demanded special category status for Bihar. The YSRCP leader demanded special category status for Andhra Pradesh. Strangely, the TDP leader kept quiet on the matter." In another post on the microblogging platform, he said, "How the political climate has changed! In the all-party meeting of floor leaders, the BJD leader reminded the Defence Minister and BJP president J P Nadda that the BJP's manifesto for the 2014 Assembly elections in Odisha had promised special category status to the state."

The Congress flagged the issue related to alleged irregularities in the exams conducted by the Union Public Service Commission, whose chairperson resigned recently for rereach Parliament when the session begins from Monday.



For the past seven years, Brijesh Pal, a daily wager, would work at a roadside dhaba in Khatauli area of Muzaffarnagar during the two months of Shravan to help his Muslim owner manage the heavy footfall of customers, mainly the Kanwariyas.

He would get Rs 400-600 and at least two meals every day for the job.

This year, however, his employer, Mohammad Arsalan, asked him to look for other jobs as he cannot afford to hire extra staff, expecting that his earnings will take a hit due to the Uttar Pradesh government's orders to owners of hotels, restaurants, food carts and eateries along the Kanwar Yatra route to display the names of their owners at their outlets.

After the Muzaffarnagar Police issued the order, the Uttar Pradesh government on Friday extended the controversial order across the state. Uttarakhand Chief Minister Pushkar Singh Dhami said similar instructions are already in place in his state as well.

"It was a good source of income as finding other jobs in this season is very difficult because construction and farm work don't happen much in the monsoon season where I could get a job as a labourer," Pal told PTI.

Motorist punches woman riding with kids in Pune; booked

In an incident of road rage, a woman riding a two-wheeler with two children was punched in the face by a motorist in Pune city after she advised him to drive properly, police said on Sunday.

A case has been registered against the 57-year-old man and his wife for the attack that occurred at Baner-Pashan Link Road on Saturday, an official said.

The victim, Jerlyn Dsilva, a marketing head at a Pune-based luxury hotel, shared a video of the incident on social media, which showed her bleeding profusely from her nose.

In another video, Dsilva said she was riding towards Baner on a two-wheeler with two children when a man in a

car did not give her way. "While on my bike with the two kids, the old man driving his car did not let me

ride ahead. I told him to drive properly. He then lowered the car window and verbally abused me," she said.

Dsilva claimed that after she managed to pass the car, the driver tailed her, forcing her to stop on the side of the road.

"The man stopped his car, blocking my way, got out angrily, grabbed my shirt, and punched me three to four times in the face," she alleged

in the video. Dsilva claimed that when she attempted to take the car keys to prevent the man from fleeing, his wife, who was in



No mention of caste-based discrimination, tweaks in references to B R Ambedkar's experience about the discrimination, referring to the Harappan civilisation as "Sindhu-Sarasvati" are also among the changes in the textbook developed according to a new curriculum.

"The Greenwich Meridian is not the first prime meridian. There were others in the past. In fact, many centuries before Europe, India had a prime meridian of its own! It was called madhya rekha (or 'middle line') and passed through the city of Ujjayini (today Ujjain), which was a reputed centre for astronomy over many centuries. "Varahamihira, a famous astronomer, lived and worked there some 1,500 years ago. Indian astronomers were aware of the concepts of latitude and longitude, including the need for a zero or prime meridian. The Ujjayini

meridian became a reference for calculations in all Indian astronomical texts," the textbook reads.

In the new textbook, the river finds a prominent place in a chapter on the "Beginnings of Indian Civilisation", where the Harappan civilisation is referred to as the "Indus-Sarasvati" or "Sindhu-Sarasvati" civilisation. It says the "Sarasvati" basin included major cities of the civilisation -- Rakhigarhi and Ganweriwala -- along with smaller cities and towns. The river, according to the

new textbook, "today goes by the name of 'Ghaggar' in India and 'Hakra' in Pakistan (hence the name 'Ghaggar-Hakra River')" and is now seasonal.

textbook for Class 6 is a heavily-truncated amalgamation of what were earlier three separate books for history, geography and civics published by the National Council of Educational Research and Training (NCERT).

"We have tried to keep the text to a minimum by focusing on the 'big ideas'. This has enabled us to combine in a single theme inputs from several disciplines -- whether history, geography, political science or economics," NCERT Director Dinesh Saklani writes in the introductory chapter of the new textbook.

What has been culled drastically is the detailed exploration of the kingdoms of ancient India, such as those contained in four chapters of the old book that have been deleted from the new. This includes accounts of the kingdoms of Ashoka and Chandragupta Maurya, including the role of Chanakya and his Arthashastra as well as the dynasties of the Guptas, Pallavas and Chalukyas, and the work of Kalidasa.
