- CV Point earn rate is calculated per Rs. 200.
- Any transaction amount less than Rs. 200 will not be considered for CV Point calculation, milestone calculation for 2000 Bonus CV Points and annual milestones calculation for Complimentary Premium Economy Ticket Vouchers.
- CV Points calculation for the CV Point program will be done basis every billing cycle.
- CV Points will be issued to cardholder's Club Vistara account every billing cycle, within 5 working days from the statement generation date.
- Any fee or financial charge levied by the Bank is not considered as an eligible transaction for calculation of CV Points or 2000 Bonus CV Points.
- Spends done on customers Add-on credit card will be considered for the threshold calculation of 2000 Bonus CV Points if the Add-on card is also in its 2nd, 3rd, 4th billing cycle.
- CV Points will not be applicable on EMI Conversions, Balance Transfer & Cash Withdrawals.
- Any reversal, refund of transaction and conversion of transaction to EMI will lead to reversal of CV Points for that particular transaction.
- For the spends done on Add on card, CV points will be accorded to the primary card holder's account only.
- The complimentary Premium Economy Ticket Vouchers on crossing annual spends milestones will be issued to cardholder's Club Vistara account every billing cycle on calculation of net spends, within 5 working days from statement generation date.
- Utilisation of complimentary Premium Economy Ticket Vouchers provided on Club Vistara IDFC FIRST Credit Card will be basis availability and will come under the purview of our partner TSAL and not the Bank.
