Police are investigating a shooting that took place in the capital which left one adult female dead.

become effective on Thursday and according to Dr. Minnis, it was introduced because of the growing public health concern and the need to protect the health and well-being of the Bahamian population as the coronavirus (COVID-

19) spreads globally.

The ban is in addition to restrictions already in place for China, Iran, Italy and South Korea.

"This restricted travel list of countries will be continuously monitored and updated as necessary," Dr. Minnis said during his televised national address on

"All Bahamian nationals and residents returning to The Bahamas through any point of entry from any of the restricted countries or an area where community infection and spread is present will be quarantined or be placed under self-isolation upon arrival and are expected to follow the protocols of

the Ministry of Health."

The prime minister advised that Bahamian nationals or residents returning to The Bahamas who have been abroad and believe that they may have been exposed to COVID-19 are asked to contact the Ministry of Health's hotline or their local health provider.

"Non-essential travel by Bahamian nationals and residents and other countries is highly discouraged," Dr. Minnis said

"Let me repeat this. If you do not need to travel overseas at this time, I highly urge you to remain at home.

Dr. Minnis also reminded Bahamians of some the symptoms of COVID-19.

"Common signs of infection include respiratory symptoms, fever, cough, shortness of breath and breathing difficulties," he said.

"In more severe cases, infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

"Most people who contract this virus will fully recover. But there are a number of people who are particularly vulnerable, including the elderly and those with chronic diseases, such as hypertension and diabetes, and those with compromised immune systems.

"We do not know how long this crisis will be with us.

"Hand washing is among the most important hygiene measures in preventing the spread of infection.

"Standard recommendations to prevent the spread of infection include regular hand washing with soap for at least 20 seconds, and covering the mouth and the nose when coughing and sneezing."

Elderly Man Shot Dead by Police

An elderly man was fatally shot after exchanging gunfire with police officers at the Fox Hill Police Station on Friday, shortly before 7 a.m.

Police said the man, who was out on bail for grievous harm, arrived at the Fox Hill Police Station to sign is as customary for persons on bail and after producing an identification card, he then produced a firearm pointing it at

the officer, which then forced that officer and another female officer to retreat to the back of the station.

According to Chief Superintendent of Police Solomon Cash, police noticed the same male suspect, who appeared to be in search of them.

"The officers produced their weapons, discharged at the male suspect, who also fired on the officers," he said.

"The male suspect then ran west along Ferguson Street and the officers pursued him. At this point, there was an exchange of gunfire, both between the male suspect and the officers. The suspect was fatally shot."

Cash added that the victim was in his seven-

He told reporters on the scene that after the shooting the victim was searched and found in possession of two pistols.

When asked if it's protocol for officers to retreat when faced with

such situation Cash said yes.

"You want protect your life as much as possible. You know, even though officers may be armed, if a gun is pointed at you, before you have an opportunity to let go. Have you been shot and killed? So the officers did the right thing around in that case until he was able to prepare himself better to engage the suspect." Cash said.

Also Cash mentioned that at this time

police do not know the intention of victim, but investigation continues.

This is the fifth police involved shooting and the fourth fatality according to The Bahama Journal's records.

Cash reiterated comments made by National Security Minister Marvin Dames who recently stated that if criminals engage police officers, they will lose.

"I can't speak to the intent of people. But I can tell you that we, the

police, are mandated to protect and serve and our constitutional rights. We have to protect our lives first and then we will protect those of the citizens of The Bahamas. So, I would say to persons out there who would think about engaging the police, I would say that they should cease," Cash said.

"Both officers were unharmed, but are traumatized. No one else was injured in this latest police involved shooting."

Acting Minster of Health Jeffrey Lloyd, Chief Medical Officer Dr. Pearl McMillan and other health officials confirmed the first case of the virus yesterday during a press conference at the Ministry of Health.

The patient is receiving care in a designated isolated area of the Princess Margaret Hospital (PMH), according to health officials.

Also, the patient's family and social con-

tacts are currently being investigated to establish the source of her infection.

Lloyd said on Friday, the patient went to PMH after showing signs of a respiratory issue. She was then tested following morning and early Sunday morning her test was confirmed positive for COVID-19.

With the first confirmed case of COVID-19, steps are being taken which includes expanded testing, Lloyd further explained.

"We made the deci-

sion to expand our testing, have a heightened sensitivity for persons presenting with influenza like symptoms due to lessons learnt from countries that have diagnosed cases in keeping with this enhanced surveillance approach," Lloyd said.

Over the past several weeks, health officials have been providing update on COVID-19 through various outlets, as first cases of the virus being confirmed in n e i g h b o u r i n g Caribbean countries

Health officials would confirm and shared that they would have taken the necessary steps to prepare for the virus if was hit our shores.

According Dr. McMillan, there more plans being put in place as the virus is evolving.

"We know that Doctors Hospital health system also has a plan for how they will deal with cases. Our plan is evolving and we are actually seeking to put in place a surge capacity plan in the the event

we get a large number of cases that we need to manage," she said.

Dr. McMillian also confirmed that there is about 100 test kits in country and about eight were used so far.

Health officials are seeking to enhance the country's testing capacity.

However, the acting minister of health is encouraging and to get their information and updates from credible sources on COVID-19.

"I want to use this opportunity to appeal to the public to remain calm and follow and implement the advisories relating to personal hygiene and overall infection prevention control," Lloyd said.

Health officials encourage persons who may have any respiratory systems of fever cough, or shortness of breath to call their doctor's office or the Ministry of Health COV-19 hotline at 376-9350, 376-9387 or 376-9357.

Amnesty International calls for release of artist and prisoner of conscience

LETTER TO THE EDITOR

Cuban artist Luis Manuel Otero Alcántara is a prisoner of conscience, imprisoned solely because of his consciously held beliefs, and should be released immediately, said Amnesty International today. A key leader in the movement opposing Decree 349, a dystopian law that stands to censor artists, he is detained and awaiting a trial that was initially expected on 11 March, but has since been delayed.

"It is absolutely shameful that the Cuban administration continues to stifle any voices that are not aligned with the official position. Luis Manuel Otero is a prisoner of conscience and we urge the Cuban government to release him immediately and unconditionally" said Erika Guevara-Rosas, Americas director at Amnesty International.

According to the information Amnesty International has obtained, Luis Manuel Otero Alcántara appears to be charged with "insults to symbols of the homeland" (Article 203 of the Penal Code), an offense inconsistent with international human rights law and standards, and "damage" to property (Article 339).

According to NGO Cubalex, in the past 30 months, authorities have arbitrarily detained Luis Manuel more than 20 times. Prior to his detention, he had announced on Facebook that he planned to participate in a protest convened by LGBTI activists after alleged state censorship of a movie featuring two men kissing.

In an interview with Amnesty International in 2019, Luis Manuel said: "I'm like the tip of the iceberg. We are talking about an endless number of artists in Cuba. [The authorities] come after me, because as I am supposedly the most visible of the youth, activists-artists, they send the message 'Well, if we lock this one up, look what we can do to you lot."

Cuba is the only country in the Americas that prohibits Amnesty International from visiting.

The organization asks all artists, journalists and LGBTI activists to call on the Cuban authorities to immediately and unconditionally release Luis

Manuel Otero Alcántara. Background information

Under Decree 349, all artists, including collectives, musicians and performers, are prohibited from operating in public or private spaces without prior approval by the Ministry of Culture. Individuals or businesses that hire artists without the authorization can be sanctioned, and artists that work without prior approval can have their materials confiscated or be

substantially fined. Under the new decree, the authorities also have the power to immediately suspend a performance and to propose the cancelation of the authorization granted to carry out the artistic activity. Such decisions can only be appealed before the same Ministry of Culture (Article 10); the decree does not provide an effective remedy to appeal such a decision before an independent body, including through the courts.

The decree contains vague and overly broad restrictions on artistic expression. For example, it prohibits audiovisual materials that contain, among other things: "use of patriotic symbols that contravene current legislation" (Article 3a), "sexist, vulgar or obscene language" (Article 3d), and "any other (content) that violates the legal provisions that regulate the normal development of our society in culmatters" (Article Furthermore, it makes it an offence to "commercialize books with content harmful to ethical and cultural values" (Article 4f).

International human rights law and standards require that any restriction to the right to freedom of expression, including through art, must be provided by law and formulated with sufficient precision to avoid overly broad or arbitrary interpretation or application, and in a manner that is accessible to the public and that clearly outlines what conduct is or is not prohibited

As signatory to the International Covenant on Civil and Political Rights (ICCPR), Cuba is required to refrain from acts that would defeat the object and purpose of the treaty. Article 19 of the ICCPR specifically protects the right to freedom of expression, which includes the "freedom to seek, receive and impart information and ideas of all kinds…" including "in the form of art".

Amnesty International has previously expressed concern that Decree 349 is likely to have a general chilling effect on artists in Cuba, preventing them from carrying out their legitimate work for fear of reprisals.

Article 203 of the Penal Code, one of the provisions under which Luis Manuel appears to be charged, is inconsistent with international standards as its effect is to limit freedom of expression. Amnesty International opposes laws prohibiting disrespect of heads of state or public figures, the military or other public institutions, or flags or symbols (such as lèse majesté and desacato laws).

Turbulent Times Ahead

The Bahamian people must be prepared for the most turbulent times that the Bahamian economy has experienced in many decades. Following the trend announced by U.S. President Trump, our Prime Minister Dr. Hubert Minnis last night said the government will not allow visitors to the Bahamas from The United Kingdom, Ireland and Europe for the next twenty days.

While we know that the world is facing a crisis due to the Coronavirus, we thought President Trump over-reacted when he banned visitors to the United States last week. Indeed, many European leaders have the same view. However, since America is the largest economy in the world and is able to print money, the Trump decision could probably be justified by his countrymen. As for the Bahamas whose main industry is tourism, the decision by our government is questionable. The American President also delivered another body blow to the Bahamian economy when he ordered all Cruise Ships to the Caribbean to suspend operations for thirty days. This came after Royal Caribbean Cruise Lines had announced stringent rules for passengers and insisted that they would continue cruises to the Bahamas.

In addition, many airlines have drastically reduced flights in the United States and Europe. What has effectually happened is that the tourism industry has come to a virtual standstill with far reaching negative consequences for the Bahamian economy and the livelihood of thousands of Bahamians. These measures also come at the peak time in the hotel industry and when revenue in this period is needed for operations for the entire year.

We are forced to ask a number of questions on the justification of certain decisions being made. The main one is this: are we making these decisions because other countries are doing so, and how are they impacting our economic and social circumstances. For instance, the Prime Minister announced that schools will be closed until April 14th. What is going to happen between now and then for students to return to their classes? Why should schools be closed on every Family Island, day including the small schools in the southern Bahamas?

Our economy has not grown in the last two decades and has not recovered from the global recession of 2008. To compound matters, there have been a series of Hurricanes over the last five years which have created consternation in the economy. What is needed now are measures to mitigate the damage done.

We have a structural problem in the Bahamian economy. The U.S economy has been strong for years and although our tourism numbers show an increase in tourist arrivals, the impact has not been felt in the general economy among ordinary Bahamians. The problem exists because the economy is out of balance due to the contraction of the financial services sector.



These times call for energy in the government to develop a vision to diversify our economy. This has to be a national effort. We have had many warnings. We had 911, hurricanes and now we have a world virus that can ruin our economy and our way of life. We need to be able to feed ourselves and to be less reliant on foreign elements for our very survival.

MAJOR CRUISE LINES SUSPEND SAILING

Nassau Anticipates More Berthing Requests

International Association (CLIA) announced that several major cruise lines, including Royal Caribbean, Carnival, Norwegian, and MSC, will voluntarily suspend sailing operations to and from U.S. ports for 30 days due to the novel coronavirus, COVID-19 pandemic. Disney also suspended its sailings through to the end of March 2020.

In a statement on Sunday, Nassau Cruise

Port added that most cruise ships at sea will continue with their itineraries as planned as the cruise lines prepare to temporarily suspend North American service.

"We anticipate that some cruise lines may request to berth ships at Nassau Cruise Port during the suspension period. These ships may contain a relatively small number of crew members who will spend this time here in port. These cruise lines will provide a Declaration of Health to Bahamas

Customs and Immigration as part of the application for entry into The Bahamas," the statement said.

"The Declaration of Health will describe any health concerns of any person onboard the ship. The crew is subject to the COVID-19 protocols of the Bahamian government at the time that they apply for entry."

Nassau Cruise Port explained that it has been and remain in constant communication with the major cruise lines and CLIA, Ministry of Health, Ministry of Tourism and other key stakeholders as this situation unfolds.

"Our cruise line partners have undertaken extraordinary measures to safeguard their crew, passengers, shareholders, and other stakeholders, and we have and will continue to benefit from their efforts," Nassau Cruise Port said.

"We support their difficult decision to temporarily suspend sailings amid this global public health crisis. Everyone's health and safety are our paramount concerns."

According to Nassau

Cruise Port, this very unfortunate situation will not derail its construction plans.

"We expect to begin demolition of the warehouse at the port by the

house at the port by the end of the month, subject to obtaining the necessary approvals," the statement said.

"Over the next few

weeks, we will review our health and safety protocols in anticipation of the resumption of cruise visits to Nassau and to improve the safety of the port environment in the short-term and long-term.

"This may include technological upgrades, enhanced security screening measures, and a review of our medical procedures, among other efforts. We are committed to the health of our passengers, employees, port stakeholders and the entire Bahamian and global communities as we navigate this challenging situation."

"I advise the public that we live in the era of fake news, therefore, all relevant information should be accessed from reputable sources. The official websites of the Bahamas government, the Center for Disease Control and the World Health Organization are recommended information sources," Davis said.

"Cooperate with all public service announcements, including travel advisories, released by the government.

"Follow all established personal hygiene and health protocols at home and when using public facilities. These include washing hands under running water with soap for at least 20 seconds."

The PLP leader also called on the government to have a comprehensive response to and an economic forecast in light of the potential economic fallout given the recent announcement by U.S. President Donald Trump on the schedule of cruise ships leaving U.S. ports for the next 30 days.

"It is the considered view of the PLP that legislation is needed as a standard national and government response in these extreme and unusual circumstances. The parliament debated and passed legislation on official action in the event of a natural disaster such as a hurricane and legislation is necessary in the event of drastic external shocks emanating

from bio-attacks and public health crises," Davis said.

"The PLP as always stands ready to assist the government in protecting the health, safety and general wellbeing of our people."
