United States Special Presidential Envoy for Climate (SPEC), John Kerry shot down the suggestion that the U.S could pay "climate reparations". In fact, when he testified at a House of Foreign Affairs Oversight and Accountability Subcommittee hearing on the State Department's climate budget back in July this year, Mr. Kerry, based on international media outlets, exclaimed: "No. Under no circumstances".

According to online publication Reuters, "The United States has backed the creation of a funding mechanism to address the loss and damages incurred by vulnerable countries as result of major or recurring disasters that was secured at the COP27 conference in Egypt last November, but the deal did not spell out who would pay into the fund or how money would be disbursed".



Given the numerous projects planned, Mr. Cooper asserted that room capacity must and will be increased. "I think we will increase overall room capacity in the next three years by perhaps 30 percent maybe 40 percent," he anticipates.

He said he did not have the numbers in the front of him, but thinks it will be fairly dramatic if the government is able to quickly get these projects going.

"In South Eleuthera, for example,"

he said, "we have the Ritz, that's making fairly significant progress; Cotton Bay, you know there's talks there as well of steady progress in South Abaco.

There are two very large projects in the \$800 million range, so I expect if we are able to really get these projects going quickly in the next three to five years, I would say that we'd be able to dramatically increase room capacity."

While he believes the fastest way to grow the economy is through foreign direct investments, the Deputy Prime Minister said he hopes to see greater Bahamian investment in the Bahamian economy.

He told his audience that the Bahamian economy has recovered at a healthy rate since the pandemic withreal GDP growth of 14.4 per cent in 2022 and 17.0 per cent in 2021, outperforming regional peers.

He said, "by all indications, we are projected to continue to see GDP growth for the foreseeable future. We are not sitting still either, -- we are revamping domestic and foreign direct investment policies to ensure a supportive environment. We are improving both internal systems and external ones to ensure we have the most productive and efficient practices," said Mr. Davis. The Prime Minister reminded the business leaders that The Bahamas is a tax-neutral jurisdiction that openly welcomes investors whose vision for their businesses aligns with our labour market and economic needs.

"While we are considered a taxneutral or low tax region, which can be an appealing prospect for investors, our international record of compliance with international transparency and accountability standards is stellar. In fact, in December 2022, we became only the sixth nation in the world to become largely compliant with the Financial Action Task Force's 40 recommendations related to compliance with anti-money laundering, counter-terrorism financing, and transparency standards.

"Our resilient external position is bolstered by the second highest level of foreign exchange reserves among our regional peers, and our national debt management strategies are working government deficits are on a downward trajectory," he said.

Mr. Davis asserted, "in essence, when you invest in our safe harbour, you can be sure you are investing in a stable environment with responsible government practices that will give your investments the opportunity to

thrive unimpeded. From a (Tourism) industry perspective, we are primed for continued expansion.

"We have built on our standing as a regional leader in tourism over the past two years with year-over-year increases of 233 per cent between 2021 and 2022, and over five million tourist arrivals in the first half of


"We've focused investments on increasing air arrivals throughout our islands and improving our core experiences through new cruise port facilities. We are on track for record breaking year, even as we are investing in new initiatives for future growth.

"Moving forward, we are working to attract major tourism investments, especially on our less populated Family Islands, each of which offer its own local and very special version of truly idyllic paradise. We're building new airports across our islands and building on progress in attracting eco-tourism resorts and experiences, as well as sports and cultural tourism opportunities.

"Our financial sector continues to provide a strong foundation for economic stability and investments, with assets representing about 164 percent of GDP in 2022, "said the Prime

He told his audience, "The Bahamas is rich with opportunities in a diverse range of sectors, and the list of emerging opportunities grows every day. Our commitment to sustainable practices, economic growth, and good governance makes us an ideal partner for investments."

### Road Trafflc Department PUBLIC NOTICE

FOR IMMEDIATE RELEASE

Last year, the Government of The Bahamas confirmed its intention to modernize the transportation sector in the country. A key component of this plan is to create opportunities for small business ownership in the tourism and hospitality industry, the success of which is largely dependent on the discontinuation of the unlawful and unfair practice of franchise leasing.

The Road Traffic Department supports entrepreneurship and diversification and to demonstrate its commitment to ending this unfair practice, franchises were issued to public service drivers who for decades, operated under unlawful "lease arrangements". Additional franchises were also issued to new market participants. The Road Traffic Department wishes to advise members of the public that the number of available franchises (taxi, livery, self-drive and other public service plates) have been fully subscribed for New Providence Island. New franchises may be granted when plates are surrendered, or franchises revoked.

New applications will be placed on hold to enable the Road Traffic Department to complete an assessment of all franchise plates. As a part of this assessment, the Board reserves the right to require franchise holders to show cause why license plate(s) should not be surrendered to the Department of Road Traffic immediately. All dormant/inactive plates should be surrendered to the Road Traffic Department in accordance with section 27 of the Road Traffic Act.

The decision to place new applications on hold is to allow for the full completion of the assessment process and to avoid oversaturation in the public transportation industry. Interested persons remain eligible to apply, however, applications will only be processed and advanced as issued plates become available in proportion to the franchises sought by applicants. Franchise approvals for which conditions have not been satisfied within the ninety (90) day period will expire and applicants will be required to re-apply.

The Ministry of Transport and Housing will provide an update to members of the public once the assessment process is completed. Members of the public are reminded that the Road Traffic Department and the Ministry of Transport and Housing are committed to acting in a transparent, responsible, and fair manner that supports national development.

As the Road Traffic Department is committed to being transparent and open with this process, persons who have submitted applications can contact the Franchise Unit, Road Traffic Department for assistance.

Continuing he listed, "Director Brenda Bullard-Colebrook Department of Local Government; Deputy Director Carol Roach also at the Department of Information of Technology; Deputy Director Faustin Major-Smith at Immigration; and the most recent Director of Immigration Keturah Ferguson, but don't forget, Melanie Roach, a Director of Works, and Kayleaser Devaux-Issacs at ZNS.'

Dr Sands goes also claims that seven female Family Island administrators were also sent home, asking what message is being sent out.


Minister Cooper explained that in the East End of Grand Bahama there are the natural beauties of the Lucayan Park and the sun bars; and

### **PM Davis Calls** On U.S To **Reconsider On Climate Matters**

This was the backdrop of Prime Minister Philip Davis's comments when he called on the U.S to reconsider its position on climate change matters and the impact climate change has on Small Island Development States.

"I wish to call upon them [U.S] to revisit a statement that was made by John Kerry where they are declining to consider assisting Small Island Developing States (SIDS) in respect to some loss and damage particularly for those over the last several years which is burdening most of our Small Island Developing States with the debt incurred as a result of recovery efforts following hurricane events.

And so, it is clearly important [and] I'm hoping that they [U.S] could revisit that question and we could firmly address it and come out with concrete outcomes at COP28, in Dubai, when we meet," PM Davis said.

In less than 100 days the 28th Conference of the Parties to the U.N Framework Convention on Climate Change or COP28 will be held in Dubai. The COP28 UAE (United Arab Emirates) intends to bring world leaders together who are then expected to "to deliver transformative Climate Action" at Expo City

"The United States plays a very import[ant] [role] on most issues that impact the global community. They are viewed as leaders in most aspects of issues impacting the global landscape; and so their role at COP[28] is particularly important and significant for the advancement of the issues that impact Small Island Developing States (SIDS), like ourselves.

"And, so, it is expected that they continue to lead but lead in a way that is sensitive to our needs and that is responsive to our needs, the prime minister said.

"Climate reparations" suggests liability on the U.S's part as SIDS contribute very little to or not at all to climate change, particularly when it comes to carbon emissions which are warming oceans and causing more intense hurricanes.

At COP27, held in the green city of Sharm El-Sheikh, Egypt, participating countries agreed to set up a fund – a Loss and Damage Fund - to assist vulnerable countries that have seen climate related natural disasters.

"I know the declaration that came out of the African Union's meeting, in that they called their pre-COP meeting to enable them to do with one voice; not dissimilar to what we did last August when we called all the Caribbean leaders together and we went to COP[27] with one voice and was able to make a difference in respect to [the] loss and damage debate. And so, that is very useful.

"And when you look at that declaration, their issues and concerns are not dissimilar to


ours. We are having our Caribbean meeting at the End of this month in Grenada where we will craft our declaration to enable us to come out with one voice," Prime Minister Davis

While in Chicago, Prime Minister Davis was a part of a roundtable conversation on Climate Change held at Loyola University and an interview on National Public Radio focused on climate change, according to a statement from the OPM.

During his time in Chicago, "The Prime Minister also urged action on fair climate finance to help small island nations like ours prepare for the new climate era and described our country's steps to grow stronger, including scaling up our mitigation and adaptation initiatives, working with scientists to map and protect our carbon-absorbing seagrasses, and strengthening our new Youth Guard, in which young Bahamians will work alongside our national security forces to offer communities support before and after storms.

"Prime Minister Davis was in Chicago, Illinois, on Monday, working to deepen ties to city and state leaders and the Obama Foundation to promote investment opportunities in our country's tourism, clean energy, and digital assets sectors; to advocate for action on our country's climate change agenda; and to celebrate 50 years of Independence with Bahamians who reside in Chicago," the statement added.

### TRANSFORMING A FISHING VILLAGE-TYPE ECONOMY TO A SERVICE ECONOMY

PART 3: THE 21ST CENTURY

By the 21st Century when Perry Christie and Hubert Ingraham came on the scene to take the reins of government after succeeding Sir Lynden Pindling, Tourism was a big business worth billions of dollars. Over the years, the Bahamian economy faced several challenges like the global meltdown in 2008 and the continuous efforts by the European Union to blacklist The Bahamas, yet tourism grew and developed.

Since 1992, there have been four Prime Ministers and each Administration has placed a progressive stamp on the tourism agenda. It is this refined action by successive governments that has been able to keep The Bahamas as a leading destination in the Caribbean Region. Even though from to time there may be hiccups in the industry, Bahamian people on the whole, I believe, understand and appreciate the importance of tourism to our economy and the role it has played in enhancing our quality

By 2000 there was an upgrade of hotel properties in The Bahamas. There was an upgrade properties on Paradise Island by Sun International with a billion-dollar investment by Sol Kerzner. There was John Issa's SuperClub Breezes, Butch Stewart's Sandals Royal Bahamian and Hutchinson Whampoa's purchase of the

Holiday Inn and Lucayan Beach Resort and Casino in Grand Bahama. Airlift was expanded and legislation was passed to encourage cruise ships to stay in port longer. There was also an expansion of the product when cruise lines started developing their own islands, i.e. Half Moon Cay by Holland America in the Berry Islands.

A new \$300 million cruise port was constructed at Prince George Dock in order to accommodate the mega cruise ships which are now in operation. This is a part of the redevelopment program for Downtown Nassau.

Hurricane Dorian and COVID-19 were two serious setbacks for the Industry, yet the Davis Administration after being in office for about two years has been able to ratchet up the industry to pre-Dorian and COVID-19 levels.

The future looks bright for the industry, as it is apparent that a three-phase agenda has been launched to continue the forward development thrust - Family Island refurbishment of airports, the redevelopment of Downtown Nassau via the demolition of dilapidated buildings and overseas promotion of The Bahamas in new destinations.

Tourism has been good for The Bahamas; however, the country has experienced External Shocks, like 9/11, over which it had no control. These Shocks created substantial economic setbacks for the country because of the lack of economic diversity. Presently, Tourism is carrying the country again as there are no activities on the horizon to highlight economic diversity. The Pindling Government initiated some diversity programmes and policies. Prime Minister Christie attempted to diversify the economy via agriculture with the introduction of the Bahamas Agriculture and Marine Science Institute (BAMSI). In this era of technology, there are new technologies which can be introduced in order to prepare our youth for the technological advances which are here like Artificial Intelligence (AI).

The Bahamas has become a residual economy of the United States. This means that once an activity or technology is prevalent in the U.S., it will reach here because we have developed the consumer culture, owing to U.S. TV advertisements and our travel, to mimic Americans. It is this pattern of behaviour that drives Bahamians.

There was a time when Tourism was thought to be a fickle industry. Some saw it like the goose that laid the golden egg; however, we have not been shortsighted hence the maintenance of this valuable industry. We, must, however, find ways to sustain it. Economic diversification is one avenue.

# ON THE RIGHT TRACK

The Davis administration is now celebrating its second anniversary in governing The Bahamas and the vast majority of the electorate is quite pleased with the performance.

There was a scientific poll released at the beginning of this week which showed a sixty percent approval in the population for the government led by the Honourable Philip Davis. A man from humble beginnings in Old Bight, Cat Island, he has shown all and singular that he has the capacity, the intellect and indeed the emotional intelligence to run the affairs of state. There has been no government since the Pindling administration after Majority Rule that has been more popular.

Mr. Davis and his colleagues have been able to properly reopen the economy since COVID-19 and has set the tourism industry on a growth path where the country will boast of the arrival of eight million visitors this year. In addition, we now see a reduction in fiscal deficit and positive signals all around.

Now political leaders throughout the Caribbean and the Americas point to the Bahamas as a wellgoverned nation. While many challenges remain, such as the need to reduce the cost of energy and electricity to Bahamians, there is evidence of a serious concern on the part of the government and plans are afoot to bring relief in this regard.

In resetting his government for the rest of its term, the Prime Minister and his team must seek to bring focused attention on Grand Bahama and Abaco which have been the second and third largest revenue producers for the government.

In Grand Bahama, pressure is being placed on The Grand Bahama Port Authority to adhere to the Hawksbill Creek Agreement and to fulfill its responsibilities. believe that the Freeport model put in place in 1955 is now an anachronistic. The principals of the Port have made a tremendous profit on their investments over the last 68 years. It is now time to sell their shares, preferably to the government and move on.

It is clear that the Port Authority does not now possess the capacity to move Freeport forward. The days of the grand

promoter, the late Edward Saint George, are over. Before him, Wallace Groves and his partner Jack Hayward did well to attract foreign investors to Grand Bahama, but that era is past. Any investments in Freeport now would be driven by the government and not the Port. The discerning international investor will look to the government for concessions and not the Port.

If the Port Authority had the kind of interest in developing Freeport as it had decades ago, it would have reinvested in the construction of an airport after Hurricane Dorian destroyed the Freeport Airport four years ago.

We believe that the Bahamian people, especially those who reside in Freeport agree with Prime Minister Davis that GBPA must move out of the way of progress. It can no longer hold on to the ownership because of ego or to be socially accepted by their friends in high places around the

Beyond all of this, Bahamians in Freeport must be more patriotic and nationalistic and believe that 50 years after Independence they and their government should wholly own Freeport in the national interest.

We believe that Prime Minister Davis and his government are on the right track and must make a serious offer to the two families of Freeport to purchase the shares in that company which has been running a "Company Town" with an economy which has been stagnant from the beginning of this century.

The Owners of Freeport have made a tremendous contribution to the overall development of The Bahamas and the country is grateful.

However, while other Family Islands in the Bahamas have been showing real growth and development, the Freeport economy is not moving and it appears that only the government has the capacity to stimulate the growth needed with new policies.

We suggest that both sides must now meet in conclave to find the way forward for the social and economic prosperity of the Bahamian people.

But, a proper building site, specifically for public use in hurricanes or other major disasters is yet to see as much as a groundbreaking ceremony.

Guess what? Our colonial government did not build any. Our 50-year-old Independent Bahamas government did not build any. So much for independent thinking. Dragging colonial baggage is another story. Ministry of Good Sense, where are you?

As a matter of full disclosure (not at all like the Mps annual obligations), I can't say wh ether or not proposals have been made, and plans are in the offing for such shelters. But no announcements have been forthcoming, despite a recent near brush with that major hurricane Lee still out there in the

# Man and **Toddler Son** Die in Bizarre Incident

Postmortem and toxicology examinations are expected to be conducted to determine the exact cause of death of a father and son who both died mysteriously during a bizarre incident in the early morning hours on Tuesday.

A 42-year-old taxi driver, identified by his wife as Jermaine Miller and his 22-month-old son Anwar Miller, died at Miller's apartment complex on Family Street, off Soldier Road west sometime around 1am.

Police reports had indicated that officers were called to the area sometime around 12:30am and when they arrived on the scene, they met a nude male on the outside the apartment complex, who reported that his landlord attempted to kill him and a female tenant, both of whom were renting

"Police were alerted to a disturbance and on their arrival, they met a male who gave them some information and told them that he was being attacked by his landlord.

When the officers went to the area that he directed them to, they met a male on the inside of his apartment.

"As they were about to confront him, he barricaded himself into a bedroom. As they were about to breach that bedroom, they heard glass being broken on the outside.

"When they went on the outside of the apartment building, they met this male jumping through a window.

"The officers attempted to subdue him. They had to chase him a short distance. He jumped a fence and went into a garbage bin," Officer-in-Charge-of the Criminal Investigation Department (CID) Chief Superintendent Michael Johnson told reporters on Tuesday afternoon.

Chf. Supt. Johnson noted that officers had to take Miller out of the garbage bin which resulted in a struggle.

"A struggle ensued between the officers and this male as they were making attempts to subdue him. Finally, they were able to arrest him. He was placed in handcuffs and brought back to the yard when EMS was contacted," Chf. Supt. Johnson said.

Asked about the toddler, Chf. Supt. Johnson said after the officers were alerted that

the landlord had a child with him, they then conducted a search of the apartment and discovered the child in one of the bedrooms.

"They were then alerted to another bedroom inside of that apartment building. When they went inside that bedroom, they met the body of a male child lying

on his back on a mattress.

"He appeared to be unresponsive. They attempted CPR; however, they waited on EMS personnel to come to the aid of that child.

"They took that child inside of the ambulance where they were trying to resuscitate him.

"He was eventually taken from that scene, and he was brought in dead," Chief Supt. Johnson explained.

'The male who was restrained by the officers was also checked by EMS personnel and he had no signs of life." The child was subsequently

identified by the mother, who has no relation to the landlord. Police say she is assisting with the investigation. Police did not reveal the mental

state of the man when questioned, nor did they give an account as to what actually caused the man and the child's death.

Chf. Supt. Johnson however confirmed that the toddler did have some discoloration of the

"We'll have to wait on the autopsy. I'm not sure of his mental capacity, but again, that is a part of our investigation that we will be checking into.

"Then again, I say we have to wait on the postmortem to determine the exact cause of his death along with the child.

"It's early in the investigation. I've given you the facts thus far, although there's some sensitive information that I wish not to disclose, but we are progressing in the investigation very efficiently. Of course, at the end of this investigation, you will be abreast as to what our findings

The head of CID noted that security cameras in the area are helping police with their investigation.

Bahamas Christian Council President, Bishop Delton Fernander, who was present at the police press briefing, said he was saddened by the news of the death of the father and son.

He encouraged persons who may have family members that display erratic behaviour to reach out and seek help; contact the church.

"We are making ourselves available as we did before with the tensions that are arising. We're going to work again to open up the hotline in short order. We will seek the spot again we did it during COVID when we opened up the hotline for prayers.

"I think as we counsel this family. As we go and try to bring relief to the situation, we realise that as a society, we've got to intervene when things are going




