### Chapter 1. Version 1.4 enhancements

There are a number of enhancements in this release of the Virtual I/O Server (VIOS).

#### Virtual I/O Server enhancements

VIOS V1.4 delivers improvements in usability, simplification, security, connectivity, maintenance, and user management. As part of an IBM<sup>®</sup> System p / Tivoli collaboration effort, a number of core Tivoli<sup>®</sup> products have been enabled to provide leading-edge virtualization monitoring capabilities for Virtual I/O Server. In addition, new POWER<sup>™</sup> platform enablement and new storage solutions and interconnects are enabled with VIOS V1.4.

#### Virtual I/O Server (VIOS)

- POWER6
  - VIOS enablement for POWER6<sup>™</sup> System p
- Lightweight Directory Access Protocol (LDAP)
  - Centralized user management
- Simple Network Management Protocol (SNMP)
  - Standard interface used for monitoring and management
- New storage subsystems: nSeries and NetApp subsystems, iSCSI and Fiber Channel attachments, and new interconnects: SAS (for disk attach), SATA (optical controller)
- · System planning and deployment upgrades
  - The system planning and deployment tool helps simplify the process of planning and deploying System p and virtual I/O. The tool also supports the planning and deployment of the virtual I/O partitions. Additional information can be found at the following Web site:

- Integrated Virtual Ethernet (also referred to as HEA or Host Ethernet Adapter)
  - VIOS's Shared Ethernet Adapter (SEA) supports bridging virtual Ethernet to HEA
- GVRP (GARP VLAN Registration Protocol)
  - Automatic registration of VLANs to external switches
- VIOS CLI improvements: security, maintenance, user management, usability
- Integrated Virtualization Manager (IVM) adds support for System Plan Management
  - Web UI and command line support was added for System Plan Management
- Tivoli Storage Manager (TSM) client

# **Chapter 5. Update to chlang command for Customers in Japanese Locales**

Customers in Japanese locales should use the **chlang** command to force messages on the left to appear in English. Without this option, messages during the boot sequence are corrupted.

To change the Virtual I/O Server's locale to Japanese, the user needs to issue the following command: chlang -msg C@lft -lang ja\_JP
