

Deed. Isam (X) Vaughan of Amelia Co. to David Vaughan of same. D. Feb. 1, 1784. Consid: 5 shillings. 50 acres in Amelia Co. on Long Branch, adj. lines of Quarles, Lipscomb and Wilkins, and the old Harrikin road. Wit: John Bridgforth, James Bridgforth & Richard Lipscomb. Pro: Apr. 23 [no year given] by 2 wit.

Deed. John Trent of Albemarle Co. (Va.) to William Trent of Amelia Co. D. Feb. 12, 1754. Consid: 10 pounds. 100 acres in Amelia Co., being part of 221 acres surveyed for John Trent on March 11, 1742, adj. lines of William Watson, Frederick Foard & Charles Hinton, with woods, houses, orchards, etc. Wit: Robert Standfield, Fredrick Foorde, Peter Clarke & George (X) Foorde. Pro: Feb. 28, 1754 by Robert Standfield & Fred. Ford.

Deed. Edward Tabb & Jane, his wife, of Amelia Co. to John Wingo of same. D. Oct. 22, 1798. Consid: \$268. 134 acres in Amelia Co., being tract where Tabb lives, adj. lines of William Clement, John Hughes, said John Wingo, Edward Booker, and the road. Wit: Jesse Hillsman, Joshua Chaffin, Samuel Ford & William Burton. Pro: Apr. 25, 1799 by 2 wit. & ordered cont'd.

Jane Tabb, wife of Edward Tabb, relinquished her dower right in the 134 acres of land described in the immediately preceding deed in the presence of Joshua Chaffin & Samuel Ford on Oct. 22, 1798.

Bill of Sale. John (X) Sadler of Amelia Co. to Charles Featherston. D. Oct. 7, 1795. Consid: 12/3/10. 3 feather beds; one table; 4 chairs; 3 pewter dishes; all my pewter and earthen ware of every kind whatever; 2 iron pots; one Dutch oven; and all and every kind of household furniture which I possess. Wit: John G. Jefferson & William Harrison. Pro: Apr. 28, 1796 by one wit. & ordered cont'd.

Deed. Agnes (X) Seay, widow of Jesse Seay, of Amelia Co. to Josiah Hatchett of same. D. Feb. 14, 1789. Consid: 35 pounds. 65-1/3 acres in Amelia Co. adj. lines of Swan Thompson, Col. Paulin Anderson & Gideon Seay. This tract is 1/3 part of 196 acres that Jesse Seay, dec'd., owned, and is her lawful dower. Wit: Joshua Chaffin, Gideon Seay & Abraham Lockett. Pro: July Court, 1789 by 2 wit. & ordered cont'd.

Deed. John Tabb to Philip Whitehead Jackson & Co. D. Apr. 29, 1786. Consid: 1000/0/5. 300 acres in Amelia Co. "on which the court house of said Co. now stands," with all buildings, yards, orchards, etc. This property is to be paid for by Jackson & Co. over a term of 5 years, to commence on Dec. 25, 1786, and to be paid in installments of 200 pounds per annum before each
