

Uber

At Uber, we have outlined goals regarding our greenhouse gas (GHG) emissions, including several goals that have been approved by the Science Based Targets initiative. A general overview of our goals, our progress towards those goals, and our methodologies for measuring our GHG emissions (including our Scopes 1, 2, and 3 GHG emissions) and our progress can be found in our [ESG \(environmental, social, and governance\) Report](#)¹ which speaks as of the date of its publication.

Uber pursues its sustainability-related commitments without a significant reliance on voluntary carbon offsets. However, we do make strategic use of voluntary carbon offsets to address hard to abate emissions or emissions from specific modes, markets, or time frames lacking feasible low or no carbon solutions. As such, we have made limited purchases of carbon offsets in specific contexts. Below is a table of the offsets we have purchased across our business in 2022 and 2023:
