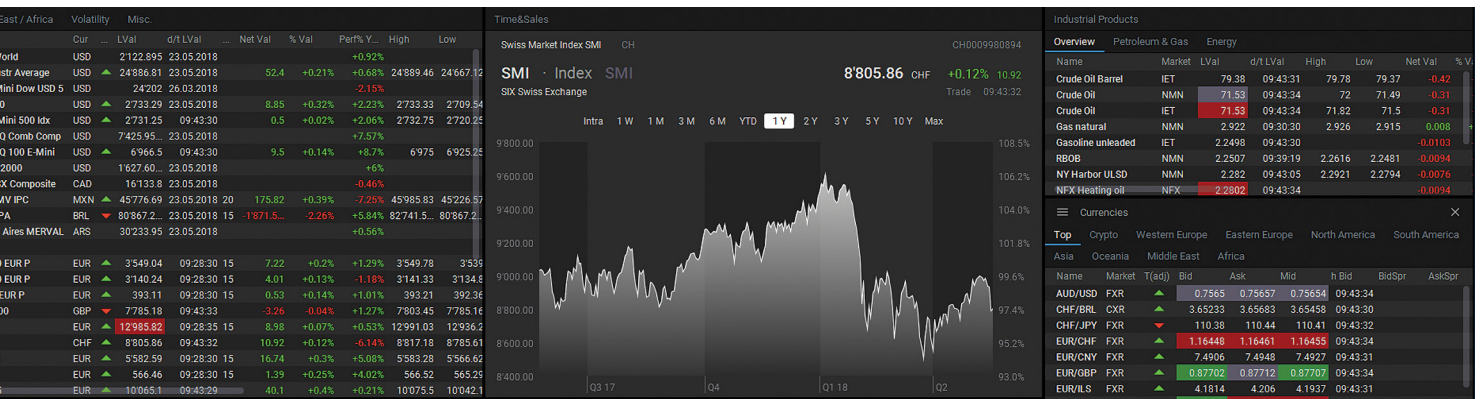

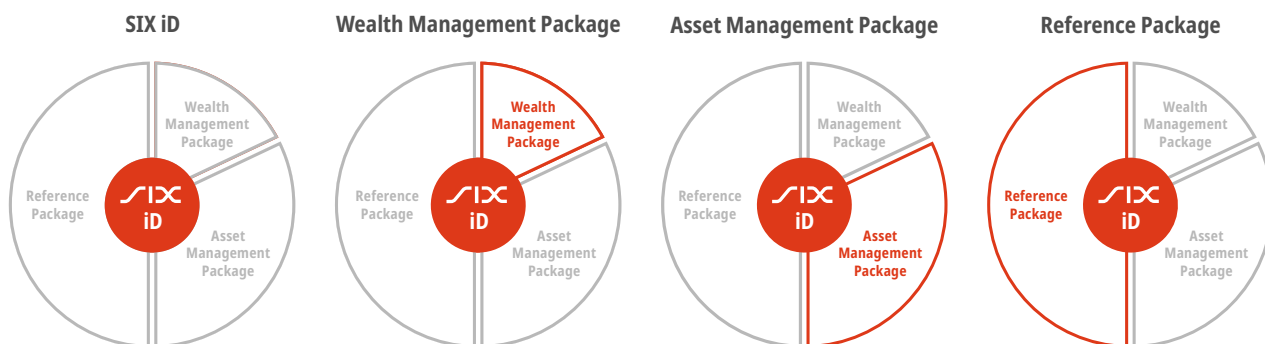
You can also seamlessly look up market activity by dragging and dropping identifiers between windows, or from external applications into SIX iD. So, you will always get the content you need, right when you need it.
