The connection to the oraise **Exchange Services | SIX Repo** platform can be implemented in various ways, including secure leased lines and secured internet connections. There is no software VPN client required on the trader desktop.

As an option, oraise offers a post trade reporting tool that connects to the backend using the CO:RE API and transforms received post trade messages to a text document. This post trade information can be conveniently downloaded via secured file transport protocol (SFTP) for backoffice use.

oraise **Exchange Services | SIX Repo** encompass qualified monitoring and reporting as well as the implementation of all regular releases and updates. These will be installed and provided according to SIX Repo's release schedules.

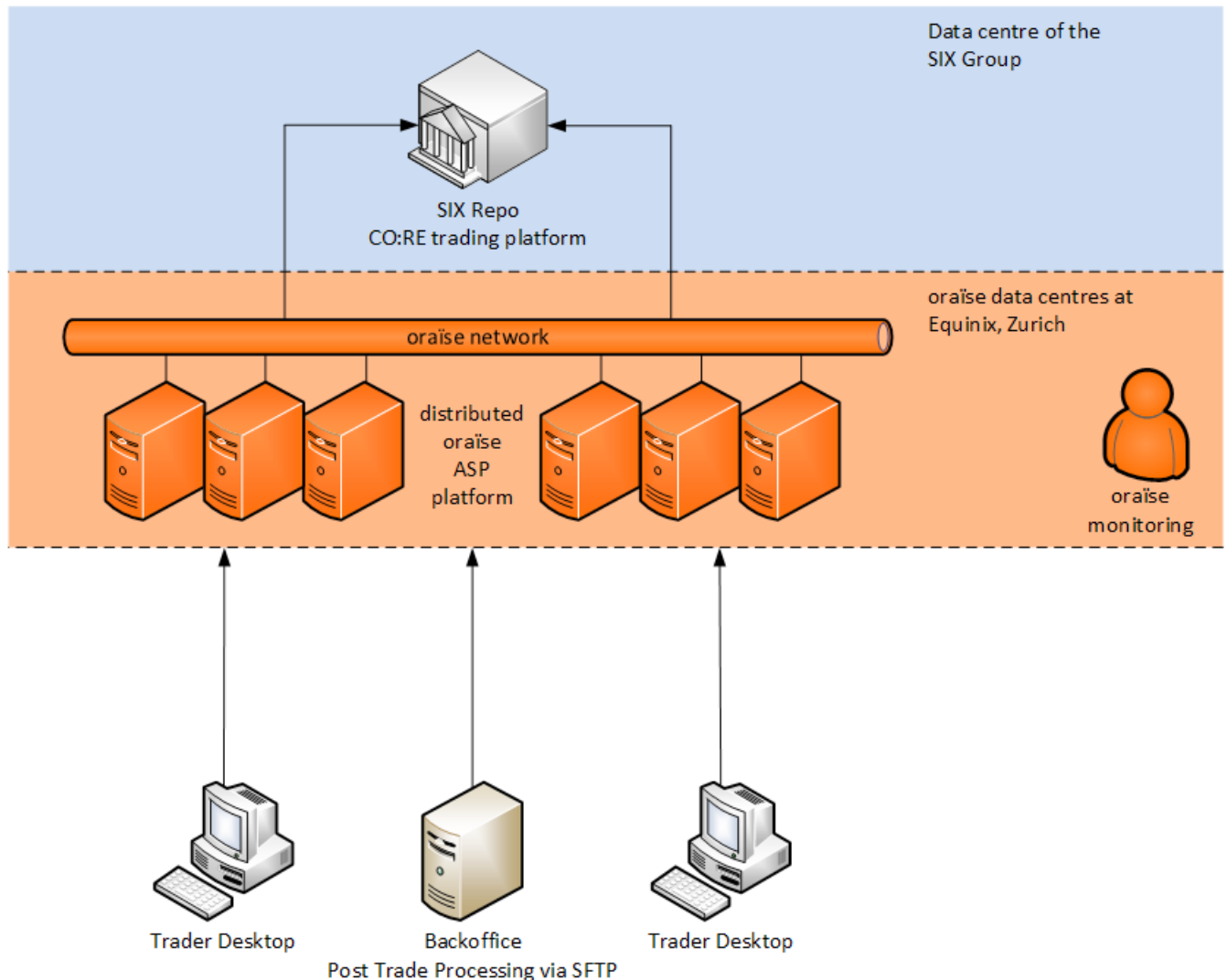
