## **Additional US State-Specific Privacy Disclosures**

This additional state-specific privacy disclosure page ("Disclosure") supplements the Amazon Ad Server Privacy Policy and is effective as of June 28, 2024. The Amazon Ad Server Privacy Policy describes the personal information that we collect, the sources from which we collect it, the purposes for which we use it, the limited circumstances under which we share personal information, and with whom we share it. These additional disclosures are required by certain state privacy laws and provide a Notice at Collection under the California Privacy Rights Act:

- 1. **Categories of personal information collected and disclosed for a business purpose**. - 6. California Privacy Rights Act Retention Disclosure. We keep your personal information for as long as it is required in order to fulfill the relevant purposes described in the Amazon Ad Server Privacy Policy, as permitted or required by law, or as otherwise communicated to you.
- 7. California Privacy Rights Act Non-discrimination Disclosure. Amazon Ad Server will not discriminate against any consumer for exercising their rights under the California Privacy Rights Act.
- 8. **Targeted Advertising Disclosure**. Amazon Ad Server processes personal information for the purposes of targeted advertising as that term is defined under certain state laws.

## 11. Annual Reporting for 2023.

<u>Access Requests</u>. In 2023, Amazon Ad Server received 256 requests from customers to initiate the data access process. All 256 requests were processed with a median return time of less than 1 day.

<u>Deletion Requests</u>. In 2023, Amazon Ad Server received 12 requests from customers to initiate the data deletion process. For 2 of these customers, their request was not fulfilled because the customer did not complete the verification process or canceled the request. The remaining 10 requests were processed with a median processing time of less than 1 day.

<u>Correction Requests</u>. In 2023, Amazon Ad Server did not receive any requests from customers to correct their data.
