Introduction

Follow the steps below to get started with your new camera.


Step 1. Download Tapo App

Get the Tapo app from the App Store or Google Play, or by scanning the QR code below.



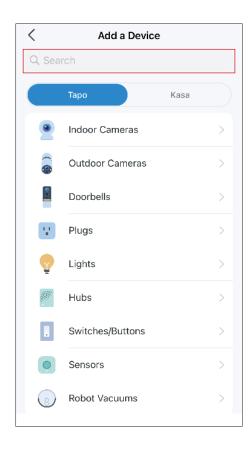
Step 2. Log In

Open the app, and log in with your TP-Link ID. If you don't have an account, create one first.



Step 3. Add Your Camera

Tap the \bigoplus button > Add Device in the app and search for your model. Follow the app instructions to complete setup.



Mount Your Camera


When you finish adding your camera in the Tapo app, you can set it on a table or shelf. You can also mount it using the provided anchors and screws. Follow the steps below to mount your new camera.

1. Mark Position

Place the mounting template where you want the camera.

For wall mounting, drill two holes through two circles.






2. Affix Screws


Affix two mounting screws with the help of mounting template.

For wall mounting, insert two anchors into holes and screw the screws into the anchors.




3. Secure Camera
