Unity License Grant Program Qualification Criteria

Unity Technologies SF (“Unity”) may provide educational version Unity Software (as defined in Unity’s [“Terms of Service”](#)) licenses at no cost* to “Qualified Institutions” around the world. A Qualified Institution includes educational institutions accredited by an authorized governmental agency within its applicable local, state, provincial, federal, or national jurisdiction and has the primary purpose of teaching its enrolled students, or that is otherwise separately approved in writing by Unity, and non-profit institutions verified by Unity or its partners. Educational version Unity Software can be used for learning, teaching, and training. US-based nonprofits will access the Education Grant License at a discounted cost through a third party partner, Techsoup (or another entity as notified by Unity).

A Qualified Institution includes the following:

- Government-accredited public or private universities, colleges and vocational training centers that grant government-approved degrees, diplomas or certificates
- Accredited public or private elementary and/or secondary schools providing full-time instruction for grades (levels) anywhere from kindergarten up to 12 (any, a “School”***).
- Education consortiums, districts, ministries, departments of education where each member is a School;
- Accredited research institutions with a grant less than \$200,000 USD to be applied to a project using Unity;
- Administrative offices or boards of education of other qualified institutions; or
- Non-profit institutions (ie: libraries, hospitals, museums) verified by Unity or its partner:
 - US based nonprofits will access licenses through Techsoup (or another entity as notified by Unity); or
 - Non-US based nonprofits will access licenses through Unity.

Additionally, if a Qualified Institution wishes to apply grant funds to a project which uses Unity (“**Project**”), such grant amount applied to the Project must not exceed \$200,000 USD.***

Organizations that are not Qualified Institutions include, without limitation, the following, unless separately approved by Unity in writing:

- Training centers;
- Religious institutions, hospitals, health care systems and libraries that are operating for profit; or
- Research institutions or laboratories that are affiliated with a Qualified Institution using Unity software for research, industry, or commercial use, who should use Unity Pro or Enterprise, as applicable pursuant to the Terms of Service.

() Unity reserves the right to change the definition of “Qualified Institution” and to charge for the educational version Unity Software at any time and without prior notice. Further, use of the educational version Unity Software is subject to the [Terms of Service](#). Amongst other restrictions in the Terms of Service as of the date of this announcement, Unity Software may be used solely for educational purposes and may not be used for any commercial or research purposes.*
