

## Registration Agreement

**This Registration Agreement contains additional terms and conditions for the registration of the Top-Level Domains detailed at Appendix A.**

The registration of these Top-Level Domains globally follows the prescribed set of terms and conditions specified by the Internet Corporation for Assigned Names and Numbers (ICANN) and DNS Belgium vzw and its subsidiaries (together referred to as: "Registry") being the authoritative Registry. The Registrar ("1&1 Internet AG") and the Registrant ("You") acknowledge and accept that these rules are incorporated into this Registration Agreement as follows:

1. The Registrant guarantees that the registration of the domain name and the manner in which it is used does not infringe the legal rights of any third party, will not be used for defamatory purposes or contravene any other applicable laws and regulations.
2. The Registrant agrees to abide by all Registry Policies set forth on Registry's website at <https://www.dnsbelgium.be/en/documents/enduser-terms-and-conditions-brussels-and-vlaanderen> (the "Registry Website"). Further the Registrant specifically acknowledges and agrees that Registry Policies may be modified by Registry, and agrees to comply with any such changes in the time period specified for compliance.
3. The Registrant agrees to comply with all applicable ICANN requirements and policies found at <https://www.icann.org/resources/pages/consensus-policies-2012-02-25-en>.
4. Registrant agrees to comply with all applicable laws, including those that relate to privacy, data collection, consumer protection (including in relation to misleading and deceptive conduct), fair lending, debt collection, organic farming, disclosure of data, and financial disclosures.
5. Registrant agrees and acknowledges that they shall participate in good faith in any proceedings described in the applicable Registry Policies, including those applicable during Launch Programme(s), and commenced by or against a Registrant or third party.
6. The Registrant represents and warrants that it has provided 1&1 Internet AG with current, complete, and accurate information in connection with its application for a registration, and that it will correct and update this information to ensure that it remains current, complete, and accurate throughout the term of any resulting registration or reservation. The Registrant understands that its obligation to provide current, accurate, and complete information is a material element of these terms, and that Registry reserves the right to deny, cancel, terminate, suspend, lock, or transfer any registration or reservation if it determines, in its sole discretion, that the information is materially inaccurate.
7. The Registrant shall indemnify, defend and hold harmless his provider, 1&1 Internet AG, the Internet Corporation for Assigned Names and Numbers (ICANN), Registry and their respective contractors, service providers, and the members, shareholders, directors, managers, each of their owners, officers, employees, affiliates and agents of each of them and all other persons involved in the registration process from and against any and all claims, damages, liabilities, costs and expenses, including reasonable attorney's fees and costs and any other expenses (including on appeal) arising out of or related to the registrant's domain name registration,

including, without limitation, the use, registration, extension, renewal, deletion, and/or transfer thereof and/or the violation of any applicable terms or conditions governing the registration or the use of the domain. The registrant shall not enter into any settlement or compromise of any such indemnifiable claim without 1&1 Internet AG's prior written consent, which consent shall not be unreasonably withheld and this entire indemnification obligation shall survive the termination or expiration of the Registration Agreement for any reason.

8. The Registrant agrees to comply with the operational standards, policies, procedures, and practices for the Registry TLD established from time to time by Registry in a non-arbitrary manner and applicable to all registrars, including affiliates of Registry and consistent with ICANN's standards, policies, procedures, and practices and the Registry Agreement with ICANN.
9. All domains under these conditions are registered by 1&1 Internet AG as accredited Registrar. Should a domain be registered incorrectly by 1&1 Internet AG or any other person involved in the registration process, e.g. not according to the order, Registrant hereby irrevocably consents to all necessary measures being taken for the correction of such mistake. Registrant agrees to immediately correct and update the registration information for the Registered Name during registration term for the Registered Name, failure to correct this information shall constitute a breach of this Agreement.
10. For disputes over the rights to domains, a worldwide Uniform Domain Name Dispute Resolution Policy (UDRP) and Uniform Rapid Suspension System (URS) has been developed by ICANN and adopted by all accredited Registrars. All domains subject to this agreement are governed by this UDRP and URS. Registrant hereby agrees that all disputes on the rights to such domains, especially arising out of trademarks, names or other intellectual property rights, shall be governed by the UDRP which can be found at <https://www.icann.org/resources/pages/udrp-2012-02-25-en> and URS which can be found at [newgtlds.icann.org/en/applicants/urs](http://newgtlds.icann.org/en/applicants/urs) and comply with the requirements set forth by Registry for domains registered during the Sunrise Period, including the mandatory Sunrise Dispute Resolution Policy.
11. The Registrant consents to the use, copying, distribution, publication, modification, and other processing of Registrant's Personal Data including personal data by Registry and its designees and agents. This data is stored within the contractual commitments and transferred to other persons inside and outside the European Union involved in the registration process, including specifically (but not limited to) the USA, and published in the ordinary way, including public access to so-called Whois databases, to make the identification of the holder of the domain possible. Registrant acknowledges and accepts that this data can be published and made available to anybody in public data storage units, together with his domain, date of registration and expiration. Registrant further accepts that if it submits information from a country other than the country in which Registry servers are located, the Registrant's communications with Registry may result in the transfer of information (including Registrant's membership account information) across international boundaries; and the Registrant consents to such transfer.
12. Registrant acknowledges and agrees that Registry reserves the right, in its sole discretion, to disqualify the Registrant or its agents from making or maintaining any registrations or reservations in Registry's TLD if it is found to have repeatedly engaged in abusive registrations.

13. Registrant accepts that Registry are entitled to, at any time, to verify (a) the truth, accuracy, and completeness of any information provided by the Registrant (the "Registrant Information"), whether directly, through any of the Registrar's of record or otherwise; and (b) the compliance by the Registrant with the applicable Registry Policies. 1&1 Internet AG and the Registrant shall fully comply and cooperate with Registry in connection with such verification and furnish all available documentation as Registry may reasonably require to complete the verification.
14. Registrant acknowledges that it is prohibited from distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law. Registrant accepts that the consequences for any such activities (as consistent with applicable law and any related procedures) shall include suspension of domain names.
15. 1&1 Internet AG and Registry expressly reserve the right to deny, reject, cancel, delete or transfer any registration or transaction, or place any domain name(s) or other transactions or registry lock, hold or similar status, that it deems necessary, in its discretion; (a) to protect the integrity and stability of the Registry registries or the Registry System; (b) to comply with any applicable laws, government rules or requirements, requests of law enforcement, or any dispute resolution process; (c) to avoid any liability, civil or criminal, on the part of Registry, as well as its affiliates, subsidiaries, officers, directors, and employees; (d) for violations of this Agreement, including, without limitation any exhibits, attachments, or schedules hereto; (e) following the outcome of a Sunrise Reconsideration Proceeding (as defined in the respective Registry Policies) or (f) to correct mistakes made by Registry or any Registrar in connection with a domain name registration. 1&1 Internet AG and Registry also reserve the right to place a domain name on registry hold, registry lock, or similar status during the resolution of a dispute.
16. Registrant acknowledges that 1&1 Internet AG and Registry will have no liability of any kind for any loss or liability resulting from the proceedings and processes relating to the Sunrise Period or the Land Rush Period, including, without limitation: (a) the ability or inability of a registrant to obtain a Registered Name during these periods, and (b) the results of any dispute over a Sunrise Registration.
17. Registrant accepts that the Registry will have non-uniform renewal registration pricing such that the Fee for a domain name registration renewal may differ from other domain names in the same or other Registry.
18. ICANN reserves the right to modify the UDRP and URS at any time. 1&1 Internet AG as accredited Registrar shall implement any such revision speedily and these will become binding upon the Registrant. Any revised version will be posted at: <https://www.icann.org/resources/pages/consensus-policies-2012-02-25-en>.
19. 1&1 Internet AG reserves the right to amend the terms of this Registration Agreement from time to time or to add alternative forms of Registration Agreement. 1&1 Internet shall provide Registry with an active link to its Registration Agreement currently in effect, including any amendments or alternative forms thereto. The Registrant further accepts that additional registration requirements may be added, from time to time, in order to comply with new ICANN policies or to comply with certain Public Interest Commitments (PICs) applicable to the Registry as part of the Registry Agreement.

20. Notwithstanding anything in this Agreement to the contrary, Registry, is and shall be an intended third party beneficiary of this Agreement. The Registrant acknowledges that the Registry is a third-party beneficiary of the Registration Agreement and as such is entitled to enforce its rights vested by the Registration Agreement. Additionally, the third party beneficiary rights of Registry shall survive any termination of this Agreement.
21. You acknowledge and agree that domain names are provided "as is", "with all faults" and "as available." Registry, its affiliates and service providers, make no express warranties or guarantees about such domain names.
22. Registry reserves the right to modify, change, or discontinue any aspect of its Registry Services, its Registration Terms, including without limitation its prices and fees. The Registrant acknowledge and agree that Registry, its affiliates and service providers may provide any and all required notices, agreements, modifications and changes to these Registration Terms, and other information concerning its TLDs electronically, by posting such items on the Registry Website. Your continued use of a Registry TLD shall constitute your acceptance of the most current versions of those notices, agreements, modifications, and changes to these Registration Terms. In the event of any conflict between the Registration Terms and the notices, agreements, modifications and changes to the Registration Terms as posted from time to time on the Registry Website, the terms posted on the Registry Website shall prevail.
23. The Registrant represents and warrants that its use of Registry and/or Registry TLD's will not be for any illegal purpose, that any application for the Registry TLD shall be in good faith and that it will not undertake any activities with its Registry TLDs that will be in violation of the Registry Acceptable Use (Anti-Abuse) Policy.
24. The Registrant accepts that TLDs are intended for and available to applicants and registrants who are at least eighteen (18) years of age. By applying for, registering, or reserving Registry, the Registrant represents and warrants that it is fully entitled to do so.
