Renewal of Membership

Subscriptions for 2013 are due for renewal on 1 January. This reminder is being sent to all members; if you are a life member, you may safely ignore it. However, as you will have seen in the letter from the Treasurer, subscription rates have had to be increased (after 13 years) as costs have continued to rise, and can no longer be absorbed if the Friends are to operate effectively.

We should like to encourage you to arrange for payment by banker's order, and use the attached form to amend existing instructions. If you are a UK tax payer, please consider Gift Aiding your donation; and if you already do so please sign again the Declaration attached, as the form has had to be amended to reflect current HMRC requirements. You may also renew online (<u>www.athosfriends.org/membership</u>), where the appropriate forms are also available as well as further information for UK taxpayers about the Gift Aid scheme.

The minimum rates for life membership are £330, \$600, or €500 (or half these figures for those over 65). If you would like to become a life member, please indicate accordingly on the form below, completing a Gift Aid form if you are able to do so.

You may of course continue to subscribe on a yearly basis and Gift Aided subscriptions are worth a further 25%. The minimum rates are £30 for institutions and communities, £20 for individuals, and a reduced rate of £10 for students, pensioners, monastics, and the unwaged. Dollar and euro rates are shown on the attached form.
