Terms of Service

Effective Date: January 1, 2019

The terms of this agreement ("Terms of Service") govern the relationship between you and Persona Game Studio (or "Us" or "We") regarding your use of Persona Game Studio's games, websites and related services (the "Service"). Use of the Service is also governed by Persona Game Studio's Privacy Policy and other relevant policies, which are incorporated herein by reference.

You may also be required to register an account on the Service (an "Account"). By registering for an Account or otherwise using the Service, you affirm that you are the legal age of majority in your country of residence. If you are not, your legal guardian must review and agree to these Terms. If you access the Service from a third party site, such as Facebook or Google, you shall comply with its terms of service/use as well as these Terms of Service.

10.6. Equitable Remedies
