The House authorized the Vice Chancellor to constitute a committee preferably comprising the following officers/officials to decide the further course of action:-

- (iii) Retired Judge (High Court)/Senior Advocate.

The above committee was proposed in view of the Vigilance Inquiry Report communicated vide Chief Secretary to Govt. of Haryana memo No. 63/83/2019-1चौकसी-1 dated 09/12.01.2023 wherein it has been reported that "no bribe or no misuse of official position happened during recruitments in CRSU, Jind. However, a

procedural lapse regarding consideration of experience of candidate by Scrutiny committee is pointed out in the vigilance report".

Prof. J.P.Yadav, Vice-Chancellor, IGU Meerpur, Rewari suggested that the details related to the case be communicated to respective Vice-Chancellors where the members of the Scrutiny Committee (mentioned in the Vigilance Inquiry Report) are presently serving. Furthermore, Prof. Dinesh Kumar, Vice-Chancellor, Gurugram University, Gurugram suggested that while taking any decision in the present agenda item, the University Act shall be referred to look into the applicability of Haryana Civil Service Rules-2016 on the University employees with reference to Legal Advise sought by Chaudhary Ranbir Singh University, Jind.

11. To consider and approve the recommendations of the Establishment Committee of its meeting held on 21.11.2023 regarding promotion of Dr. Neeraj Singh from the post of Assistant Registrar to Deputy Registrar.
