

Empanelment of Concurrent/ Continuous Auditors in Canara Bank for the period from 1st July 2024 to 30th June 2025

How to apply:

1. Online Application shall be made through Bank's Web Site : www.canarabank.com.
2. Other modes (such as sending hard copy) is **NOT** accepted.
3. Use only Google Chrome, Mozilla Firefox and Internet Explorer 11+ browsers for best results.
4. Please go through the guidelines, terms and conditions and other instructions, thoroughly, before logging into the package.
5. Keep all the information/data like, UCN, Firm registration number and date of registration with RBI/ICAI, LLPIN, DPIN/DIN, PAN of Proprietor/Firm, GSTIN (of Auditor / Main office/branch Office); Phone number; Mobile Number; STD code; Contact person details; Contact person email id; etc., ready before entering the application.
6. Please go through this material, get acquainted with the fields and then start entering the details against the relevant columns.
7. Ensure your UCN issued by RBI and FRN issued by ICAI are entered correctly. (do not add 0000 as prefix).
8. To login to the ONLINE package, Firm UCN and FRN are the credentials.
9. While filling up mobile numbers, +91 or 0 need not be prefixed.
10. This online empanelment process is for concurrent/continuous audit of 393 branches/offices.
11. The online application format is lucid and self-explanatory. Yet, in case of assistance, the Planning Section, Inspection Wing may be contacted on working days of the Bank.

Besides above, details of CISA / DISA, Certificate course on Concurrent Audit in Banks and Certificate course on certified internal auditor details of all partners are to be kept readily available for completing the screens.

Screen 4:

Upon clicking “Next” the data in the first page will get saved. In this screen, names of the partners with details like Education qualification, membership number and contact details along with their profile is to be kept readily available. The screen will allow to enter only the details of number of partners which is equal to the number entered in screen 1. For entering second / other partner details, “Save / Add Row” has to be clicked. Upon completion of entering partner details “Next” to be clicked which will automatically save the details entered.

Screen 5: Past Experience of the Firm

Canara Bank: If the firm is having past experience in Canara Bank, the same can be entered here. The details like Branch name, nature of audit and period of conduct of audit is to be entered. If the experience is in multiple years, additional rows can be used by clicking “Save / Add Row”.

In the same way Other Bank experience is to be mentioned. If the bank is not finding place in the list of branches given, “other bank” option can be used.
