of e NAM - Invitation for Inter State trade with Tamil Nadu - Regarding.

eNational Agriculture Market (eNAM) is implemented in Tamil Nadu since 2017 in phases with the integration of 127 Markets and integration of another 30 markets is under process.

As 'One Nation-One Market' is the main concept of e NAM, Inter mandi and Inter State trade are being promoted in Tamil Nadu by issuing Unified Single Licence (USL) and necessary amendments in the APMC Act.


In Tamil Nadu, the commodities such as Copra, Groundnut, Turmeric, Cotton, Maize, Paddy, Bajra and Moth dhal are available for Inter State trade. Market committee wise commodities are enclosed in the annexure.

Traders of other States and UTs are invited to trade in Tamil Nadu **with the state USL issued by their respective States/ UTs as there is no specific restrictions in the TNAPMC Act.** The traders of Tamil Nadu are also interested to trade with Uttar Pradesh, Maharashtra, Odisha, Gujarat, and other states.

So far in Tamil Nadu, Interstate trade to the tune of 1444.289 Qtls with the value Rs.172.90 Lakhs have been done with the states of Andhra Pradesh, Telangana, Uttar Pradesh and with UT Puducherry.

It is requested to create awareness and interest among the traders of other States/UTs to trade with Tamil Nadu and also to inform the commodities available in the respective States / UTs for Inter State trade and to expand the Market access.


