NOTIFICATION

In exercise of the powers conferred under section 64 of the Himachal Pradesh Agricultural and Horticultural Produce Marketing (Development and Regulation) Act, 2005 (Act No. 20 of 2005), the Governor, Himachal Pradesh is pleased to grant exemption @10% of market fee or user charges, as the case may be, to such registered traders, who conduct business of agriculture produce as specified in the Schedule appended to the said Act, on e-NAM portal within the market area of Himachal Pradesh. This exemption will be effective for a period of two years from the date of publication of this notification in the Rajpatra (e-Gazette), Himachal Pradesh.
