Subject – Registering 'Madhya Pradesh Power Transmission Co. Ltd.', Jabalpur (M.P.) on 'Jeevan Pramaan Portal'.

Madhya Pradesh Power Transmission Co. Ltd., Jabalpur is a wholly owned Govt. of M.P. undertaking, dealing in Transmission of Electricity all over of the state of Madhya Pradesh. Currently Madhya Pradesh Power Transmission Co. Ltd., Jabalpur is having approx. 3561 pensioners and family pensioners, scattered all over India. Around 350 to 400 pensioners shall be added every year in the coming years.

Govt. of India on 10.11.2014 has launched Scheme of Digital Life Certificate for Pensioners known as 'Jeevan Pramaan'.

The Government of MP vide order No. F9-10/2014/Rule/4 Bhopal Dt. 29/11/2014 has also adopted digitalizing the Life certificate submission process by registering with "Jeevan Pramaan".

The digitalization of Life Certificate submission process by registering on Jeevan Praman Portal will help the pensioner to submit the life certificate to the Union Bank of India (the Agency) without visiting the Bank.

In view of the above, our Company desired to register itself as a 'Pension Sanctioning Authority' on the Jeevan Pramaan Portal. It is hereby requested to register and on board "**Madhya Pradesh Power Transmission Co. Ltd., Jabalpur**" as a Pensioning Sanctioning Authority on the "Jeevan Pramaan Portal" for further necessary action.

The pension of MPPTCL, Jabalpur is being centrally sanctioned by Pension Section O/o C.F.O., M.P.P.T.C.L., Jabalpur (which is proposed to be 'Pension Sanctioning Authority' (PSA) in Digital Jeevan Pramaan Scheme). PPOs are issued by 4 Regional Accounting Units of the Company situated at Jabalpur, Bhopal & Indore (which are proposed to be 'Pension Disbursing Agency' (PDA) in Digital Jeevan Pramaan Scheme). These RAOs distribute the pension through Union Bank of India, Madan Mahal Branch, Jabalpur as per agreement with the Bank (which is proposed to be 'Agency' in Digital Jeevan Pramaan Scheme).
