

**Subject: Acceptance of test report/Certification for OF (Single mode) & OFC under MTCTE scheme-reg.**

In order to further facilitate Optical fibre/Cable industry for testing and certification under MTCTE regime, following test report/Certificate are also acceptable in addition to test report from TEC designated CAB (Labs):

(i) The test report/Certificate issued by Government organisation/PSUs such as RDSO/BSNL/MTNL/ITI etc. for their own procurement/tender (in supersession of earlier clarification issued letter no 6-6/2021-TC/TEC (PtII) dated 18.11.2022).

In addition to the test report/Certificate, the applicant is required to submit the mapping of parameters tested vis-a-vis ER & annexure to ER and comply with limits/values prescribed therein. The format of mapping is annexed.

(ii) The test report issued by NABL accredited lab **till 31.03.2024.**

(iii) The test report/Certificate issued by the reputed Government Labs/ Institutes such as ITI, IITs, IISc, CDOT etc.

(iv) Further, if there are some parameters in ER on OF (Single mode) & OFC which are not covered in submitted test report/Certificate, the respective parameters shall be treated as exempted and a provisional MTCTE certificate with a validity of two years will be issued.

(v) Furthermore, the submitted test report/Certificate should not be older than 5 years from its issuance date.


2. In case of registered MSME, the witness testing may be allowed till **31.12.2024** for certification under MTCTE regime, if facility exists for testing of sufficient parameters of ER.
