The timelines for filing of returns/declarations, specific to different years by public servants under Lokpal and Lokayuktas Act, 2013 are as follows:

- 1. The first return under the Lokpal Act ( as on 1<sup>st</sup> August, 2014 ) should be filed on or before 15<sup>th</sup> Oct.,2015.
- 2. The next annual returns under the Lokpal Act, for the year ending 31<sup>st</sup> March, 2015 should be filed on or before 15<sup>th</sup> October, 2015
- 3. The annual returns for subsequent years as on 31<sup>st</sup> March every year should be filed on or before 31<sup>st</sup> July of that year.

All officers/officials are hereby directed to submit all the returns before the due date to this office. The formats are available on the web-site of this office.

- 2. In this regard, I am now forwarding beautiful a copy of the Government of tradia Notification dated 03rd July, 2015, further amending the Public Servants (Furnishing of Information and Annual Returns of Assets and Liebilities and Liebi
- 3. In view of the aforesaid notification of Public Servants (Furnishing of Information and Annual Returns of Assets and Liabilities and Limits for Exemption of Assets in filing Returns) Second Amendment Rules, 2015, the timelines for filing of returns/declarations, specific to different years, by public servants under the Lokpal and Lokayaktas Act, 2013, are as follows:
  - a. the first return (as an 1st August, 2014) (as was initially required to be filed by 15th September, 2014) can now be filed by 15th October, 2015.
  - b. the annual return (as on 31st March, 2005) (as was initially required to be filed by 31st July, 2015), can now be filed by 15th October, 2015.
  - c. the subsequent annual returns (as on 31st March of each year) are required to be filed by 31st July of that year.
- 4. In view of the above, I would like to request you to kindly bring the above mentioned position to the notice of all concerned and to issue orders towards ensuring compliance with these rules by all officers/staff in your Ministry/Department and organisations/PSUs under the control of your Ministry/Department.
