Sub: NFS – BIN Maintenance

Objective:

The objective of this circular is to provide NFS members with a list of BINs maintained at NFS for routing interbank ATM transactions through NFS network.

This will help NFS members to verify the following:

- As an Issuer, whether member bank's existing BINs are maintained at NFS, and
- As an Acquirer, whether all the BINs as per the list are updated by NFS members at their switch.

Proper updation of BINs by NFS members and at NFS shall prevent declines of ATM transactions due to non updation of BIN at either end. This will help in avoiding customer complaints.
