GENERAL INFORMATION

By accessing the Site and using the Services, You, either as an individual or a single entity, hereby fully consent to all terms contained within the Privacy Policy.

The Services are not accessible to minors (i.e. under the age of eighteen).

DATA COLLECTION

"Data" shall mean any information indicated by You voluntarily and/or collected by Hubvisor by using the Site and/or performing the Services which may include, without limitation:

Use of the Site: when You use the Site, Data about Your computer hardware and software may be automatically collected by Hubvisor by using cookies, web beacons and tags. This information can include: Your IP address, browser type, domain names, access times and referring Site addresses.

Registration and/or subscription to the Services: when registering and/or subscribing to the Services, You will transmit to Hubvisor Your name, address, phone number, email address and any other information provided to Hubvisor, if relevant.

USE AND RETENTION OF DATA

Hubvisor collects and uses the Data to (i) operate the Site, (ii) deliver the Services You have subscribed to, and/or (iii) inform and/or propose to You other products or services made available from time to time by Hubvisor.

Furthermore, Hubvisor uses the Data for business purposes, such as marketing, responding to general inquiries or customer support requests, and to provide general statistics regarding the use of the Site and the Services such as to supply and/or ameliorate Services supplied by Hubvisor.

Hubvisor may also contact You via surveys to conduct research about Your opinion of current services or of potential new services that may be offered.



TRANSFER OF DATA

The Data will not be rented, shared, or sold to third parties except as provided under the Privacy Policy.

We may share Data with affiliates, vendors, or other third parties to perform the Services on our behalf, for marketing purposes and/or for operating Hubvisor's business.

We may disclose Data to third parties when we reasonably believe we are obligated to do so by law, and in order to investigate, prevent, or take action regarding suspected or actual prohibited activities, including but not limited to fraud and situations involving potential threats to the physical safety of any person.

We may transfer Data, to a successor entity in connection with a corporate merger, consolidation, sale of assets, bankruptcy, or other corporate change.

USE OF COOKIES/TARGETED ADVERTISING

Hubvisor, and any third party authorized by Hubvisor, may collect Data on the Site using cookies, web beacons, and tags for the operation of the Site (e.g. managing user sessions), including analyzing site usage, detecting and preventing malicious behavior on the site, and improving the content and organization of the Site. We also engage other companies that will use similar methods to collect Data on our Site for analyzing site usage.
