Dear Shareholders,

With reference to the revised 'Guidance Note and FAQs on the Conduct of General Meetings for Listed Issuers' issued by the Securities Commission Malaysia ("**SC's Guidance**") on 7 April 2022, listed issuers are encouraged to continue leveraging technology in conducting general meetings beyond the Movement Control Order.

In line with Practice 13.3 of the Malaysian Code on Corporate Governance, the Company's forthcoming EGM will be conducted virtually through live streaming from the Broadcast Venue via Remote Participation and Electronic Voting ("**RPEV**") facilities. This would facilitate greater shareholder participation as it facilitates electronic voting and remote shareholders' participation. With the RPEV facilities to be provided by the Poll Administrator of the Company, Boardroom Share Registrars Sdn. Bhd. ("**Boardroom**"), you may exercise your right as a member of the Company to participate (including to pose questions via typed text to the Board of Directors and/or Management of the Company) and vote at the EGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the EGM.

Kindly ensure that you are connected to the internet at all times in order to participate and vote when our virtual EGM has commenced. Therefore, it is your responsibility to ensure that connectivity for the duration of the meeting is maintained. Kindly note that the quality of the live webcast is dependent on the bandwidth and stability of the internet connection of the participants.

Broadcast Venue

The virtual EGM will be conducted online from the Broadcast Venue, and shareholders will participate via the RPEV facilities with audio and/or video capabilities. The Broadcast Venue is the main venue in Malaysia where the Chairman of the meeting will be physically present in accordance with Section 327(2) of the Companies Act 2016 ("**the Act**") together with essential individuals in accordance with Note 1.3 of the SC's Guidance. Shareholder(s), proxy(ies), authorised representative(s) or attorney(s) **WILL NOT BE ALLOWED** to be physically present at the Broadcast Venue on the day of the EGM.

Entitlement to Participate and Vote

Only shareholders whose names appear in the Record of Depositors of the Company as at 7 December 2023 shall be entitled to participate and vote remotely at the EGM.

Lodgement of Form of Proxy

Shareholders are encouraged to go online, participate, and vote at the EGM using RPEV facilities. If you are unable to attend the EGM, you are strongly encouraged to appoint the Chairman of the EGM as your proxy and indicate the voting instructions in the Proxy Form in accordance with the notes and instructions printed therein.

If you wish to attend the EGM yourself, please do not submit any Proxy Form. You will not be allowed to attend the EGM together with a proxy appointed by you.

Please ensure that the original Proxy Form is deposited at our Share Registrar's office, at 09-27 Level 9, Berjaya Times Square, No. 1 Jalan Imbi, 55100 Kuala Lumpur, Wilayah Persekutuan, Malaysia, not less than forty-eight (48) hours before the time appointed for holding the EGM.

Alternatively, the proxy appointment may also be lodged electronically via Boardroom Smart Investor Portal ("**BSIP**") at <https://investor.boardroomlimited.com>, which is free and available to all individual shareholders, not less than forty-eight (48) hours before the time of holding the EGM, i.e. latest by Tuesday, 12 December 2023 at 10.00 a.m. For further information on the electronic lodgement of Proxy Form, kindly refer to the "**e-Proxy Lodgement**" below:-

- h. Read and accept the General Terms and Conditions by clicking "**Next**".
- i. Enter the required particulars of your proxy(ies).
- j. Indicate your voting instructions – FOR or AGAINST, otherwise your proxy(ies) will decide your votes.

- b. Login with your User ID and Password given above.
- c. Click "Meeting Event" and select from the list of companies "**7-ELEVEN MALAYSIA HOLDINGS BERHAD EXTRAORDINARY GENERAL MEETING**" and click "**ENTER**".

Revocation of Proxy

If you have submitted your Form(s) of Proxy and subsequently decide to appoint another person or wish to participate in our electronic EGM by yourself, please write in to bsr.helpdesk@boardroomlimited.com to revoke the earlier appointed proxy forty eight (48) hours before the EGM. On revocation, your proxy(ies) will not be allowed to participate in the EGM. In such event, you should advise your proxy accordingly.

Voting Procedures

The voting will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad's Main Market Listing Requirements. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting (e-Voting) and SKY Corporate Services Sdn. Bhd. as Independent Scrutineer to verify the poll results.

During the EGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules.

For the purpose of this EGM, e-Voting can be carried out by using either personal smart mobile phones, tablets, personal computers or laptops.

The polling will only commence after announcement of poll being opened by the Chairman and until such time when the Chairman announces the closure of poll.

The Independent Scrutineer will verify the poll result reports upon closing of the poll session by the Chairman. Thereafter, the Chairman will announce and declare whether the resolution put to vote is successfully carried or otherwise.

Online Registration Procedure

Please note that all members including (i) individual members; (ii) corporate shareholders; (iii) authorised nominees; and (iv) exempt authorised nominees shall use the RPEV facilities to participate and vote remotely at the EGM.

If you wish to participate in the EGM, you will be able to view a live webcast of the EGM, ask questions and submit your votes in real time whilst the EGM is in progress.

Kindly note that the quality of the live streaming is highly dependent on the bandwidth and stability of the internet connection of the participants. Therefore, kindly ensure that connectivity for the duration of the meeting is maintained.
