

# 2017 Vaping Policies in UK Councils Report

A report from The Freedom
Association's *Freedom to Vape*Campaign

November 2017

## Introduction and key findings

In November 2016, we published a groundbreaking report looking at the vaping policies of all UK councils. We have done the same again this year to see if any councils have changed their policies as a result of advice from Public Health England (PHE) which was included in the Government's Tobacco Control Plan.

In total, 391 councils responded to our freedom of information requests - a successful response rate of just under 94 per cent. The key findings of this research show that:

- 126 councils (32 per cent of those who responded) require vapers to use designated smoking areas in all or some circumstances, despite that fact that vapers are not smokers. This is an increase from 112 councils in 2016.
- When asked if councillors are due to debate the Government's Tobacco Control Plan and/or PHE's advice on vaping policies, a total of 287 councils replied no.
- When asked if the council's policy will be reviewed as a result of the Government's
  Tobacco Control Plan, 150 councils either said yes, was scheduled for review later
  this year or in 2018, or that the policy was under review a measly 38% of those
  councils who replied.

### **Background**

Electronic cigarettes are, according to Public Health England (PHE), the number one stop smoking aid in the UK.<sup>1</sup> It is estimated that there are 2.9 million vapers in the UK<sup>2</sup>, and around 97 per cent of users are current or former smokers.<sup>3</sup> The Royal College of Physicians (RCP) has stated that vaping is at least 95 per cent safer than smoking combustible tobacco.<sup>4</sup> E-cigarettes were recommended as a quit aid for smoking in PHE's 'Stoptober' campaign.

PHE has also issued advice<sup>5</sup> to organisations that they should "ensure policies are informed by the evidence on health risks to bystanders".

Nor is vaping a gateway to smoking.<sup>1</sup> In a report published in February 2016, ASH (Action on Smoking and Health) said:

"It has been hypothesised that electronic cigarettes could act as a 'gateway' to smoking tobacco among children and to the 'renormalisation' of smoking. However, current evidence suggests this

phenomenon is not occurring, at least in Great Britain. In fact, since electronic cigarettes have been on the market, smoking prevalence has declined among children. Whilst some never-smokers are experimenting with electronic cigarettes, regular use is rare among children and current electronic cigarette use is confined almost entirely to those who have already tried smoking".

Considering the overwhelming body of evidence that has (and continues to be) accumulated over recent years that shows that e-cigarettes are a vastly safer way to consume nicotine, that there isn't a risk for bystanders, and that e-cigarettes are not re-normalising smoking in any significant way, it would be reasonable to assume that councils would do everything they could to make it easy for their employees to make the switch from combustible tobacco to e-cigarettes.

As this report proves, the vast majority of councils are either willfully ignorant or have chosen to ignore the advice of respected bodies like the Royal College of Physicians.

PHE stated in 2016 that "it is never acceptable to require vapers to share the same outdoor space with smokers", however, this report highlights that 126 councils (32 per cent of those who responded) ignore this advice and require vapers to use designated smoking areas in all or some circumstances, despite that fact that many vapers are not smokers - they are using e-cigarettes as a way to stay smokefree.

Despite the Government's Tobacco Control Plan² stating that "PHE recommends that e-cigarette use is not covered by smokefree legislation and should not be routinely included in the requirements of an organisation's smokefree policy", almost 90 per cent of councils still make no distinction between smoking and vaping. Furthermore, only 38 per cent of councils who responded to our freedom of information requests stated that they would review, have scheduled reviews, or are currently reviewing, their policies as a result of the most recent advice from PHE and the Government. Many were openly hostile.

It is also worrying that councillors are generally excluded from the decision making process. When we asked "are councillors due to debate/discuss the Government's Tobacco Control Plan and/or Public Health England's advice on vaping policies?", 287 councils replied either no, or there were no plans at present. That is just over 73 per cent of those who responded.

Here is a small selection of replies that highlight the points we have been making:

- Blackpool Council replied by saying that "we have no immediate plans to review our
  existing Policy. The Council promotes a smokefree and vape-free environment to
  promote good health and the well-being of all staff, visitors, contractors and clients as
  well as to communicate a positive corporate image and set an example to other
  employers, workforces and the general public. Blackpool's Director of Public Health
  continues to advocate for smokefree and vape-free public places." This is despite the
  fact that by promoting vaping the council would be promoting the good health and
  wellbeing of staff.
- Broadland District Council said that "staff who use e-cigarettes should not 'smoke'
  these within the council's buildings and the same restrictions apply as to smokers of
  cigarettes. Vapers are able to use the designated smoking areas alternatively they may
  choose to use their own vehicle".
- **Buckinghamshire County Council** states that "staff and visitors are required to use designated smoking areas on council owned or leased property in order to vape".
- Chichester District Council said "after many years of lobbying and campaigning it is considered socially unacceptable to smoke in public places. E-cigarettes may lead to smoking becoming normalised, undermining the impact that the smoking ban has had on de-normalising smoking in public places."
- Cumbria County Council said that "use of e-cigarettes or ENDS in the workplace is currently unregulated. Extensive trials have not been undertaken to establish if they are safe and tests by Trading Standards have shown that some e-cigarettes are in contravention of product safety regulations. Using e-cigarettes simulates smoking behaviour. Allowing use of e-cigarettes can be viewed as condoning smoking. Cumbria County Council, in line with British Medical Association Occupational Medicine Committee and the Board of Science guidance, does not support the use of e-cigarettes in the workplace. It actively supports employees to stop smoking for their health and also supports actions to denormalise smoking. Consequently Cumbria County Council applies the same restrictions to the use of e-cigarettes that apply to smoking tobacco products." This is an appalling policy and the council doesn't seem to think that there's anything wrong with it.
- **Doncaster Metropolitan Borough Council** said that "the No Smoking Policy was looked at in light of Public Health England guidance that came out last year on e-cigarettes, and it was decided that the existing policy did not need to change."
- East Lindsey District Council replied by saying that "there is no established evidence
  that e-cigarettes are safe, effective or produced to any standard or quality. There is
  evidence that such products produce emissions which could be harmful to others. The
  use of e- cigarettes in the workplace is therefore prohibited." The council has no intention
  of reviewing its policy in the light of recent evidence and councillors are not due to
  debate the issue.

- Despite the 'Stoptober' campaign recommending e-cigarettes, Fareham Borough
   Council said, "We follow national campaigns when publicised. We do not encourage
   e-cigarettes as a means of smoking cessation." It obviously doesn't follow national
   campaigns very closely!
- **Great Yarmouth Council** stated that "public health experts would not recommend their use until they become a regulated product and there is clear and established evidence of safety and long term health impacts." Another council that has not read PHE's advice.
- **Hyndburn Borough Council** said that it "will consider evidence but have no plans to treat e-cigarettes any differently... We intend reviewing it [the policy] soon but not making any substantial changes". In other words, the council has made up its mind before it conducts a review and there are no plans for councillors to debate the policy.
- Newark and Sherwood District Council says that "employees who work from home or away from their main base are not permitted to smoke whilst working on Council business." As the vaping policy is the same as the smoking policy, this most bizarre, unenforceable policy, must apply to both.
- Northamptonshire County Council was the only council in the UK to refuse to give us
  a copy of its smoking policy because (1) Information is exempt information if it
  constitutes a trade secret. (2) Information is exempt information if its disclosure under
  this Act would, or would be likely to, prejudice the commercial interests of any person
  (including the public authority holding it). (3) The duty to confirm or deny does not arise
  if, or to the extent that, compliance with section 1(1)(a) would, or would be likely to,
  prejudice the interests mentioned in subsection (2).
- **Southend-on-Sea Council** does not encourage staff to use ENDS (Electronic Nicotine Delivery Systems), and said "that is not an oversight, it is by design".
- South Norfolk Council tells its employees that they may smoke or vape during their lunch breaks, but only discreetly to limit them being identified as council workers. The council goes on to suggest that "this could be achieved by covering identifiable logos or for depot staff by stepping behind a stationary refuse vehicle so they are not visible from the road etc."

The following councils plan to review/are reviewing their policies due to PHE guidance, and councillors will be consulted about any changes:

 Ashford, Bolsover, Cheshire East, Copeland, Cornwall, Dover, Durham County Council, Halton, Hertfordshire, High Peak, Inverclyde, Kent, Barking & Dagenham, Bexley, Waltham Forest, Norfolk, North East Derbyshire, Oxfordshire, Renfrewshire, Rochdale, Scarborough, Sefton, Sheffield, Shropshire, Solihull, Southampton, Staffordshire Moorlands, Stockton-on-Tees, Tendring,

That is under 7 per cent of all UK councils

Although councils in Scotland, Wales, and Northern Ireland do not look to PHE for guidance, we asked the same questions. Councils are free to set their own policies and can look to any body or report for guidance. Most councils in the devolved nations refused to answer the question as to whether or not they would review their policies as a result of advice from PHE included in the Government's Tobacco Control Plan. **East Renfrewshire** was one of the few that did, and replied by saying:

"East Renfrewshire Council is based in Scotland and considers all appropriate advice. For example, there has been recent guidance from NHS Scotland in terms of E-cigarettes published in September 2017. As such the Council would consider potential UK guidance from the relevant governing bodies or national guidance which may apply rather than only one specific publication guidance."

East Renfrewshire is very much the exception to the rule. The Shetland Islands Council replied by saying that the policy will be reviewed "only when Scottish guidance is issued". Glasgow Council, though, has one of the worst policies of any council in the UK. Instead of looking to the RCP for guidance, it instead looks to a discredited report that has been proven to be wrong:

"Impartial studies such as Harvard reports and US Food and Drug Administration research state that the vapour has been found to contain detectable levels of several known carcinogens and toxic chemicals to which users could potentially be exposed. The reports also suggest that by simulating the use of cigarettes, E-Cigarettes might reactivate the habit in ex-smokers."

Unsurprisingly, Glasgow Council doesn't have any intention to update this outdated policy.

# **Recommendations**

Councils regards themselves leaders in their communities. They often say that it is important that they set a standard that others will follow. If all of this is true, then faced with the overwhelming evidence that e-cigarettes and other tobacco harm reduction products could save millions of lives, the **overwhelming majority of councils in the UK need to change their policies.** 

Councillors are our elected representatives. They should always be involved in the decision making process.

All councils should immediately **end the policy of making vapers use designated smoking areas**.

One of the attractions of vaping over smoking is that it is something you can do indoors. No-one enjoys standing out in the cold and rain. **Introducing indoor vaping areas would encourage more employees to quit smoking.** 

Following the lead of Public Health England, all councils should promote e-cigarettes as a quit aid to staff and the wider communities they serve.

### **About Freedom to Vape**

The Freedom to Vape campaign is a non-partisan campaign from The Freedom Association. It has three main aims:

- To remove the regulations imposed on the vaping industry by the European Union's 2014 Tobacco Products Directive (TPD) (which came into force on 20 May 2016), including the ban on advertising, the maximum size of tanks, the size of e-liquid bottles, and the strength of e-liquids.
- To raise awareness of the differences between vaping and smoking combustible tobacco.

# **Sources and Methodology**

Freedom of Information requests were sent to all district, county, unitary, metropolitan, London borough councils, including the City of London Corporation, on 20 September 2017. A total of 417 councils were contacted. Here is the full list of questions asked:

- Please supply me with a copy of your council's policy on the use of e-cigarettes on council premises. This includes all council owned or leased buildings (for example, libraries, offices, museums), council owned or leased property (for example, parks, gardens, and other areas that form part of the grounds of council offices), and vehicles (for example, council owned or leased cars and vans).
- 2. Please inform me if staff are required to leave their place of work (for example, their desk or vehicle) to vape.
- 3. Please inform me if staff and visitors have to leave the grounds of council owned or leased property to vape.
- 4. Please inform me if staff and visitors are required to use designated smoking areas on council owned or leased property in order to vape.
- 5. Please inform me if your council's policy on the use of e-cigarettes differs in any way from your council's existing policy on smoking. If it does, please explain the differences.
- 6. Please detail your council's policy, if there is one, for staff smoking cessation and also if you encourage your staff to use e-cigarettes as a means of smoking cessation.
- 7. Please inform me when your policy on the use of e-cigarettes was last reviewed, if it is under review, and/or if it is due to be under review in the near future.
- 8. The Government's Tobacco Control Plan explicitly states that "Public Health England has produced guidance for employers and organisations looking to introduce policies around e-cigarettes and vaping in public and recommend such policies to be evidence based. PHE recommends that e-cigarette use is not covered by smokefree legislation and should not be routinely included in the requirements of an organisation's smokefree policy". If the council has not reviewed its policy since the publication of this control plan, does it have any plans to do so in the future?
- 9. Are councillors due to debate/discuss the Government's Tobacco Control Plan and/or Public Health England's advice on vaping policies?

Whilst every attempt has been made to ensure the accuracy of this report, a substantial number of councils chose not to answer the questions above and referred us to their relevant policies. Many of those policies are ambiguously worded, therefore we had to interpret them to get answers to our questions.
