- (a) TCI shall determine the exchanges (i.e., Rate Centre and/or Wire Centre, as appropriate) where it will provide service. C |
- (b) Service is provided at TCI's discretion within such exchanges depending on the availability of suitable facilities and equipment. |
- (c) When it is necessary for TCI to install special equipment or to incur an unusual expense to establish service, the Customer shall pay an additional charge based on the equipment installed and the unusual expense incurred. |
- (d) The Customer is solely responsible for the installation, operation and maintenance of Customer provided terminal equipment. |
- (e) Customer terminal equipment attached to TCI's network must be certified or connected through a certified network protection device in accordance with TELUS General Tariff CRTC 18001, Item 110. |
